





students.

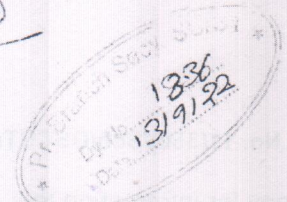
2. The scheme will run similar to the scheme Top Class College for SC


