NOTIFICATION

Subject Guidelines/Policies related with results/conduct of exams for Intermediate/ Final Semester/Annual students for B.Arch programme for the academic session 2019-20

With reference to University **Notification** dated **June 8, 2020** regarding the above, and with reference to the Advisory issued by the <u>Council of Architecture</u> dt. April 23, 2020 regarding <u>Thesis and Practical Training etc</u> following would be the guidelines for B.Arch_

(1) Under the special circumstances due to COVID 19, For the B.Arch Programme Annual scheme for the current year 2020, it is proposed to conduct the examination for all the Courses in the **Final (5th) year** in line with Univ. Notification dated June 8, 2020.

(2) In addition, as is further recommended by the above mentioned CoA advisory, it is proposed as an exception to conduct due examination the **Architectural Thesis** course as well. This course is the most crucial component of the B. Arch Programme run in the **Term –II** of the **Pre Final (4th) year** as per the B.Arch scheme.

(3) Examination for the theory course **AP-502** shall be conducted according to the guidelines decided by the University for All other Theory Course Examinations of various programmes as recommended in Item **1(a)** of the Univ. Notification dated June 8, 2020

(4) Examinations for the studio/practical courses **AP -501** and **AP- 404** shall be run in <u>online mode</u> as recommended by the council and also provided for in Item **2(f)** of the Univ. Notification dated June 8, 2020

(5) For B.Arch. programme except for AP-404, No exams to be conducted for all courses in intermediate semesters/years and their unconditional promotion to next semester/year. The students would be promoted to the next semester/year on the basis of composite 50% weightage to marks in the previous semester/year only and 50% weightage of marks in internal assessment of the current semester in each subject. (as provided in the June 8, 2020 notification).

(6) For current Fourth year, students would be promoted to the 5th. year on the basis of composite 50% weightage to marks in the previous year only and 50% weightage of marks in internal assessment of the current semester in each subject <u>except for Thesis AP-404</u>.

(7) Only for **AP-404**, total marks obtained in the **examination** (i.e. internal plus **external**), in other words internal marks plus external jury marks shall be considered in place of only internal assessment for the purpose of result and promotion.

(8) The carry forward (for the subjects in which the student has failed in previous year/semester) would be allowed for the current academic semester/year and every student would be promoted to the next semester/year, irrespective of the approved promotion criteria. However, such students would be required to clear the examinations for the subject/course in which he/she is failed/remained absent as and when examinations are held for the same in future.
