1. Eligibility and Qualifications for Assistant Professor

(a) For Medicinal Chemistry & Drug Design

1) M.Sc. 55% marks in Chemistry/Medicinal Chemistry/ Microbiology/ Biochemistry/ Bioinformatics, or an equivalent degree from an accredited foreign University.

2) Ph.D. Degree in relevant field from an Indian University, or an equivalent degree from an accredited foreign University.

3) The National Eligibility Test (NET) shall be the minimum eligibility for appointment of Assistant Professor.

(i) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR (exemption from NET shall be granted provided that candidates who have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. degree) Regulation, 2009, or the University Grants Commission (Minimum Standards and Procedure for award of M.Phil/Ph.D. degree) Regulation, 2009, or the University Grants Commission (Minimum Standards and Procedure for award of M.Phil./Ph.D. degree) Regulation, 2016, and their subsequent amendments from time to time, as the case may be, shall be exempted from the requirement of the minimum eligibility condition of NET for recruitment and appointment of Assistant Professor the University.

Provided further that the award of degree to candidates registered for the M. Phil/Ph.D. programme prior to July 11, 2009, shall be governed by the provisions. of the then existing Ordinances/Bye-laws/Regulations of the Institutions awarding the degree. All such Ph.D.

Candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor in the University subject to the fulfilment of the following conditions:

a) The Ph.D. degree of the candidate has been awarded in regular mode only;

b) The Ph.D. thesis has been awarded by at least two external examiners;

c) An open Ph.D. viva voce of the candidate has been conducted;

d) The candidate has published two research papers from her/his Ph.D. work out of which at least one is in a refereed journal;

e) The candidate has published at least two papers, based on her/his Ph.D. work in conferences/seminars sponsored/ funded/supported by the UGC/ ICSSR/CSIR or any similar agency.

(ii) A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (non-creamy layer)/differently abled (persons with Benchmark Disability PwBD) in the category of (a) Visual Impairment (VI) including blindness and low vision, and (b) Locomotor Disability (LD) including leprosy cured, dwarfism, acid attack victims and muscular dystrophy. The eligibility of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed), wherever specified, and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

(iii) A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized University, at the master's level shall also be considered eligible. (iv) The number of candidates to be called for interview for the teaching posts in the University shall be determined after screening of applications in accordance with the guidelines laid down by the University.
