#### BACKGROUND

UNESCO has given 17 Sustainable Development Goals (SDGs) in 2015, which have a substantive focus on Gender Equality (SDG 5) and Quality Education (SDG 4). But it is notable that goal on gender equality is a major challenge area with moderate or stagnating improvement for almost all the countries of the world. Women empowerment in terms of their presence in managerial positions of organizations, having rights to family planning, free from cruelty/physical violence/mental violence are the major challenges in many countries. Higher education is a platform which can help overcome these issues by research, dialogue, active participation and thereby proposing policy implications in successfully achieving this goal.

There are few specific target in these two goals which can be achieved with the help of higher education institutions internationally. These targets are as under

Target 4.3:By 2030; countries should "ensure equal access for all women and men to affordable and quality technical, vocational and tertiary education, including university."

Target 4.5: By 2030, eliminate gender disparities in education and ensure equal access to all levels of education and vocational training for the vulnerable, including persons with disabilities, indigenous peoples and children in vulnerable situations

Target 5.2: Eliminate all forms of violence against all women and girls in the public and private spheres, including trafficking and sexual and other types of exploitation

Target 5.5 Ensure women's full and effective participation and equal opportunities for leadership at all levels of decision-making in political, economic and public life

Target 5.c Adopt and strengthen sound policies and enforceable legislation for the promotion of gender equality and the empowerment of all women and girls at all levels

On the basis of these targets, the present conference aims to achieve below mentioned objectives and expected outcomes

- To identify critical disruptions/bottlenecks in effective participation and equal opportunities of women in decision making and leadership at all platforms of political, economic and public life.

- To evolve strategies and build synergy to meet these targets

The authors name and affiliation should not reflect anywhere on the manuscript for the blind review process. The total length of the paper must not exceed 10-12 A4 size pages excluding bibliography and appendices, single-line spacing, 12 font, Times New Roman, and 1" margin on all sides of the page in MS Word compatible format text. Papers MUST ONLY be submitted through E-mail at international@ipu.ac.in.

## **PUBLICATION OPPORTUNITY**

The Conference is aiming to collaborate with Scopus Indexed journals for the high quality papers. The selected papers shall be recommended for publication in those journals. The journals has their own publication policy and process which the author has to follow as suggested.
