OFFICE MEMORANDUM

While processing the proposal of foreign visit of one of the Vice-Chancellor of a University under GNCT Delhi, it was observed that the concerned Vice-Chancellor was holding the position of Director in several private companies of India and abroad simultaneously, which was neither informed earlier while taking up assignment of VC nor permission of Competent Authority was taken for continuance with such engagements. Aforesaid incidence was taken seriously by the Hon'ble Lt. Governor, Delhi and appropriate action under the extant rules against the said Vice-Chancellor, was recommended.

It has been observed that most of the Universities of GNCT Delhi have adopted CCS (Conduct) Rules through the enabling provisions in the Statute of the concerned University. As per decision of the Govt. of India in the case of the applicability of the CCS (Conduct) rules, "the Undertakings entirely funded by the Government i.e. where the whole capital is invested by the State, the activities of the employee should be restricted in the same manner as for those working directly under the Government". Further, as per provisions of Rule 15 of the CCS (Conduct) Rules regarding 'private trade and employments, no Government servant shall, except with the previous sanction of the Government, engage directly or indirectly in any trade or employment' and should not "take part except in the discharge of his official duties, in the registration, promotion or management of any bank or other company".

Keeping in view of above, it has been directed by the Competent Authority that all the VCs, of the Universities under the GNCT Delhi should submit necessarily the details of private trade or business with whom they are associated directly or indirectly, to the Secretary (TTE & HE) within 3 week's time from issue to this O.M. for seeking ex-post facto approval/orders of the Competent Authority i.e. Chancellor, Registrars/faculties of the Universities may also submit similar details to the concerned authority for seeking ex-post facto approval/order of the concerned Competent Authority as per provisions of the relevant CCS Rules or as per Act/Statute of the University, as the case may be.
