The Vice-Chancellor, Prof. (Dr.) Mahesh Verma welcomed all the members to the 54th meeting of the Academic Council of GGSIP University. Thereafter, the agenda of the meeting was taken up.

Agenda Item No. AC 54.01: Implementation of Common University Entrance Test (CUET) conducted by the National Testing Agency (NTA) for the UG programs being run in the University Schools of Studies and affiliated colleges of GGSIP University.

The Hon'ble Vice Chancellor informed the Academic Council that the University is admitting the students in the University School of Studies (USS) and Affiliated Colleges by following 3 modes of merit i.e. i) the National Level Test, ii) Common Entrance Test (CET) conducted by the University and iii) Some Post-Graduate Programme only in USS through merit basis of qualifying examination marks.

The Govt. of NCT of Delhi already allowed admission to MBA. The Admissions Shall be made based on **Common Admission Test (CAT)**. However, if seats remain vacant after exhausting the merit list of CAT, the University will consider filling up the vacant seats based on the National Level Test **Common Management Admission Test (CMAT)**. In case of seats remains vacant after exhausting the merit list of CAT followed by admissions through CMAT, the University is allowed to admit candidate by conducting its CET.

Similarly, in MCA, admission shall be made based on the **National Institute of Technology Master of Computer Applications Common Entrance Test (NIMCET)**. In case seats remain vacant after exhausting the merit list of NIMCET, the University is allowed to admit candidates by conducting its CET.

Further, the University received a letter from the Directorate of Higher Education, Govt. of NCT of Delhi; No. DHE-9(83)/PIg/2022/Misc(CUET)/3858 dated 19.07.2022 informing that the Universities which have not implemented the Common University Entrance Test

(CUET) from this year may take a call in this matter. The University announced the admission for Academic Session 2022-23 much before the announcement of CUET. Accordingly, the University conducted the CET.

The admission process for Academic Session 2022-23 is going on and the seats are vacant in various programmes after exhausting the merit of CET conducted by GGSIP University. There are students available who did not appear/ apply earlier for the CET but appeared in the CUET and as such it is proposed to adopt a merit list of CUET for considering admission against vacant seats available after exhausting the merit list of CET. Thus CUET merit list shall only be adopted wherever the University has conducted CET.

The Academic Council deliberated on the proposed agenda and resolved that the adoption of the Common University Entrance Test (CUET), a National Level Test, conducted by the National Testing Agency (NTA), shall be used for filling up vacant seats for the UG & PG programmes after exhausting the merit of CET in the programmes where CUET is applicable for Academic Session 2022-23.

Prof. J.L. Gupta appreciated that the University has prepared the mapping eligibility of CET of UG/PG Programmes meticulously and suggested that the University should prepare the Guideline for the admission to be followed.

The members were in view that the Admission Committee shall prepare the guidelines for adopting the CUET score for a particular programme considering the practice adopted by the other Universities. **The Academic Council also resolved that the University shall adopt National Level Tests including CUET for the programmes wherever applicable from the Academic Session 2023-24.** For the programme where the National Level Test is not available, the University shall conduct the CET.

Further, the Hon'ble Vice Chancellor informed the members that after approval of the Academic Council, the proposal will be forwarded to DHE for adopting the CUET in corresponding UG & PG Programmes in the Academic Session 2022-23 as above and further from Academic Session 2023-24, the CUET as National Level Test will be adopted for the admission of UG/PG programme, wherever applicable.

The Vice-Chancellor appreciated the valuable participation of all the Hon'ble members in the 54th meeting of the Academic Council and acknowledged them with thanks for their cooperation and suggestions.

The meeting concluded with thanks to the Chair.
