### VISION OF THE MOOT COURT SOCIETY

University school of law and legal studies Moot Court Committee has been set up to provide the students an opportunity to develop their interpersonal and Advocacy skills. Participation in Moot Court Competition enhances the art of researching and oratory skills of students while preparing the student to face the reality of a courtroom. It also aids in confidence building. Mooting gives a practical courtroom experience to a law student.

The aim of university is to produce committed and efficient professionals thereby contributing to the growth of legal system. Number of students aspiring to be mooters participates in various National and International Moot Court Competition throughout the year and bring laurels to the University.

#### **RATIONAL**

Moot Court is a mandatory academic activity in all leading law schools across the Country. In moot court competition participants take part in simulated court proceedings, usually involving drafting of memorials or memoranda and participating in oral arguments. The Bar Council of India Regulations on Legal Education, 2008 envisage Moot Courts as a mandatory part of the Law course curriculum. Selections through Intra Moot Competition is a well-established academic practice followed among the reputed Law Schools, Nationally and Internationally.

The University School of Law and Legal Studies has been sending teams in various National and International Moot Court Competitions since its inception. Our students have also been getting laurels to the University in various such

competitions. The Grand Intra Moot Court Competition is an effort to streamline the process by selecting the teams for all competitions to be held in one academic year in the beginning of the year, this will ensure greater participation and increase the visibility of the Law School in National and International Competitions as also better results by ensuring that teams have adequate time for preparation. Previously, the teams were selected to appear in external Moot Court Competition for each competition separately, and trials were conducted for each competition. This was both time consuming and ineffective as the teams often lost valuable time after the completion was notified before they could begin their preparations. This also results in diminished interest in Moot Court activities.

# DE NOVO MOOT COURT COMPETITON, 2022

The University School of law and legal studies, moot court committee organised De Novo Intra Moot Court Competition 2022 on 5th December 2022 for the 1st Years batch in physical mode. The moot proposition was based on the Indian contract act, 1872. The inaugural ceremony of the event was conducted and was graced by the presence of Former Dean Prof. Amar Pal Singh, Current Dean Prof. Queeny Pradhan, Faculty Convenor Prof. Rakesh Kumar and other faculties of USLLS. There was a participation of more than 30 competing teams.

Researchers test was conducted on 2nd December 2022 followed by the draw of lots and memorial exchange. The preliminary round for the competition were organised followed by the semi-final rounds in which four teams qualified from the preliminary round. This was followed by the final rounds with great zeal and eloquence. A total of 23 judges adjudged the proceedings in courtroom in good faith. The jury included experienced final year students of USLLS. The judges appreciated participants saying that their level of arguments is exemplary and went beyond the Call of Duty.

The valedictory ceremony was conducted followed by the announcement of results. Ms. Manasi Bhardwaj won the best researcher. Best memorial was won by TC-15. Mr. Shorya Garg and Best Female Speaker won best male speaker was won by Ms. Alisha Khan.


