**NOTICE REGARDING CONDUCT OF COUNSELLING/ADMISSIONS IN MBBS AT  
VMMC & SAFDARJUNG HOSPITAL & BDS AT ESIC DENTAL COLLEGE AND  
HOSPITAL FOR ACADEMIC SESSION 2019-20**

This is in continuation to Notice F.No. GGSIPU/ADMISSIONS/2019/11952 dated 13.06.2019 It is **once again reiterated that Counselling for BDS Programme at ESIC Dental College and Hospital & MBBS at VMMC & Safdarjung Hospital will be conducted by MCC.**

Vide letter no. F.No. U-12021/14/2019-MEC dated 06.05.2019 from Prof. (Dr.) B. Srinivas, Assistant Director General (ME), Director General of Health Services, Govt. of India, the GGSIP University has been informed that "As per the MCI (Medical Council of India) Gazette notification (copy enclosed), MCC (Medical Counselling Committee) is a custodian authority for conduction of counselling for all Central Government Institutes and since VMMC is a Central Government Hospital it has been decided by the Ministry that from this year (2019) onwards under Graduate Counselling for 100% (15% + 85%) VMMC and Safdarjung Hospital will be conducted by MCC as per University rules and regulations."

Further, vide meeting dated 07.06.2019 held under the chairmanship of Dr. Manju Bala, DDG (M), DGHS, Ministry of Health & Family Welfare, Govt. of India, and as per minutes communicated on 12.06.2019, it is mentioned that "ESIC Dental College and Hospital admission for 85% State Quota will be conducted by MCC which was done earlier by I.P. University."

In view of the above, all the stake holders (NEET UG 2019 qualified) desirous of seeking admission at *VMMC & Safdarjung Hospital in programme MBBS (for both All India Quota & State Quota) and at ESIC Dental College and Hospital in BDS programme (for both All India Quota & State Quota) in the Academic Session 2019-20 have to do fresh registration on MCC's website (<https://medicalcounseling.nic.in/UGCounseling>), as admissions in the mentioned colleges/courses as above in the academic session 2019-20 will be carried out by MCC.*

### **Kind Attention: Candidates who want to participate for Institutional Quota seats of Central Institutes:**

Candidates who want to participate in the Internal Quota seats of Central Institutes (VMMC & Safdarjung Hospital) may kindly note the following:

- As per the Gazette Notification of MCI, Medical Counselling Committee (MCC) is a custodian authority for conduction of Counselling for all Central Government Institutes and since VMMC & Safdarjung Hospital is a Central Institute, it has been decided by the Ministry that from this year (2019) onwards UG Counselling for 100% (15% AIQ+ 85% Institutional Quota) VMMC & SJ Hospital will be conducted by MCC as per University Rules & Regulations.
- Candidates desirous of seeking admission at VMMC & Safdarjung Hospital in MBBS Course (for both AIQ and State Quota) in the academic session 2019-20 have to Register on MCC website.
- The eligibility conditions of candidates for 85% Institutional Quota seats will be as per University Rules & Regulations. Candidates are advised to go through the University rules & regulations and eligibility conditions before choosing the Internal seats of VMMC & Safdarjung Hospital.
- There are two types of seats available at VMMC & Safdarjung Hospital, Subsidized & Non Subsidized seats in General Category which have different fee structure. However, MCC software does not differentiate between the two. Subsidized & Non Subsidized seats will be assigned to the candidates by the college authorities after allotment made by MCC, depending on the NEET merit and rank of the candidate.

This issues with the approval of competent authority.
