NOTICE

A meeting of the Equivalence Committee as constituted by the Hon'ble Vice Chancellor as per the provision mentioned in para 36 page 13 of Part-A of the Admission Brochure 2019-20 was held on 09.08.2019 to examine the eligibility criteria in respect of certain students who have been allotted seats / granted admissions in MCA, MCA (LE), M.A (Economics) and B.Tech during Online Counselling Academic Session 2019-20. The Case-wise recommendations which has subsequent approval of the Competent authority are as under for information of all the concerned:

1. The cases of the below mentioned candidates with the qualification mentioned against their names who have been allotted seat through Online Counselling in M.A Economics Academic Session 2019-20 were placed before the Committee. The decisions with regard to the representations of the below mentioned candidates is as under:

Recommendations / Decision:

The Members of the Committee deliberated the cases of the above referred candidates and taking into consideration the contents of the syllabus of their respective possessed qualification i.e. B.A, B.Com (Hons) and B.Com the recommends: that the qualification i.e. BBA / B.Com / B.Com(Hons), possessed by above referred students cannot be held equivalent to the qualification required for admission to M.A Economics as per the University eligibility criteria mentioned in the University Admission Brochure for the Academic Session 2019-20. Hence, they do not fulfilled the requisite qualification as required for M.A (Economics) as per University Admission Brochure 2019-20. The Similar cases also were declined for admission to M.A(Economics) during previous two years.

2. The cases of the Candidates who have been allotted seats in MCA, MCA (LE) through Online Counselling were also placed before the Committee for consideration and appropriate recommendation

/ decision with regard to their eligibility in the allotted course on the basis of the qualification actually possessed by them. The case wise deliberation of the recommendations:

Case 1: The representation dated 08.08.2019 is received from Nitin Chauhan regarding the eligibility of MCA programme. As per the representation of the candidate mentioned that he has scored NIMCET Rank is 1624. The University has allotted College CDAC, Noida. He has passed B.Sc (Physical Science) from University of Delhi. The College is not accepting his admission due to eligibility criteria.

The eligibility as per Admission Brochure 2019-20 for MCA programme is as below:

“Indian Nationals securing at least 60% marks in aggregate or 6.5 CGPA on a 10- point scales (55% marks or 6.0 CGPA on a 10-point scale in case of SC / ST) in (i) B.Sc. / B.Sc. (Hons) / BCA / BIT / B.Voc. (Computer Science / Computer Applications) of minimum three years full-time from a recognized University with Mathematics / Statistics as one of the subjects

OR

B.E / B.Tech. from a recognized University.”

Admission Criteria: All applicants are required to appear in NIT MCA Common Entrance Test (NIMCET) 2019 that is conducted by National Institute of Technology's on a rotational basis. The University shall not conduct its own CET for admissions, but shall be utilizing the merit prepared on the basis of NIMCET Merit for its admissions.”

Recommendations: The Committee taking into consideration the contents of the subjects mentioned in the Transcript of B.Sc(Physical Science) recommends that the qualification possessed by the candidate may be considered equivalent to the eligibility criteria as per the University Admission Brochure for MCA Programme. Hence, fulfill the eligibility criteria.

Case 2: The representation dated 08.08.2019 is received from Sankalp Garg regarding the eligibility of MCA (LE) programme. As per the representation of the candidate mentioned that he has secured CET Rank is 28 in MCA (LE). The University has allotted CDAC, NOIDA. He has passed B.Sc (Physical Science) from Delhi University.

The eligibility as per the Admission Brochure 2019-20 for MCA (LE) programme is as below:

Bachelor of Computer Applications / B.Sc. (Information Technology) / B.Sc.(Computer Science) degree with mathematics as a course at 10+2 level or graduate level from a University recognized by the UGC with a minimum of 55% marks in aggregate.

Admission Criteria: 1. Admission shall be on the basis of the merit of the written test / CET.

Recommendations: The committee after having gone through the contents papers mentioned in the Transcript for B.Sc(Physical Science) of the candidate is of the opinion that the candidate does not possessed the Bachelor of Computer Applications / B.Sc. (Information Technology) / B.Sc.(Computer Science) as specified as per the eligibility criteria and hence, the qualification possessed by him cannot be considered as equivalence to the eligibility criteria mentioned in the Admission Brochure 2019-20 for MCA(LE).

Case 3: The representation dated 08.08.2019 is received from Simran Garg regarding the eligibility of MCA. As per the representation she has mentioned that she has passed B.A (Prog). Whether she is eligible or not for taking admission in MCA programme on the basis of eligibility of B.A.(Prog).

The eligibility as per Admission Brochure 2019-20 for MCA programme is as below:

Indian Nationals securing at least 60% marks in aggregate or 6.5 CGPA on a 10- point scales (55% marks or 6.0 CGPA on a 10-point scale in case of SC / ST) in (i) B.Sc. / B.Sc. (Hons) / BCA / BIT / B.Voc. (Computer Science / Computer Applications) of minimum three years full-time from a recognized University with Mathematics / Statistics as one of the subjects

OR

B.E / B.Tech. from a recognized University.

Admission Criteria: All applicants are required to appear in NIT MCA Common Entrance Test (NIMCET) 2019 that is conducted by National Institute of Technology's on a rotational basis. The University shall not conduct its own CET for admissions, but shall be utilizing the merit prepared on the basis of NIMCET Merit for its admissions.

Recommendation: The Committee is of the opinion that the qualification possessed by the Candidate i.e. B.A(Prog) from University of Delhi cannot be considered as equivalence to the eligibility criteria mentioned for MCA programme as per Admission Brochure 2019-20 in GGSIP University. Hence, She does not fulfill the eligibility criteria for admission to MCA to GGSIP University.

Case 4: The representation dated 08.08.2019 is received from Rohit Kumar Mahaseth regarding the eligibility of MCA programme. As per the representation he has mentioned that he has secured NIMCET Rank is 1151. The University has allotted College i.e. CDAC, Noida. He has passed BCA programme from Maulana Mazharul Haque Arabic & Persian University, Patna. The College is not accepting his admission due to eligibility criteria.

The eligibility as per Admission Brochure 2019-20 for MCA programme is as below:

Indian Nationals securing at least 60% marks in aggregate or 6.5 CGPA on a 10- point scales (55% marks or 6.0 CGPA on a 10-point scale in case of SC / ST) in (i) B.Sc. / B.Sc. (Hons) / BCA / BIT / B.Voc. (Computer Science / Computer Applications) of minimum three years full-time from a recognized University with Mathematics / Statistics as one of the subjects

OR

B.E / B.Tech. from a recognized University.

Admission Criteria: All applicants are required to appear in NIT MCA Common Entrance Test (NIMCET) 2019 that is conducted by National Institute of Technology's on a rotational basis. The University shall not conduct its own CET for admissions, but shall be utilizing the merit prepared on the basis of NIMCET Merit for its admissions.


Recommendations: The Committee is of the opinion that since the candidate has passed BCA with one of the subject Computer Mathematical foundation hence, he is eligible for admission to MCA.

Case 5: The representation of one of the candidate i.e. Manish who has been allotted seat in MCA programme Academic Session 2019-20 was also placed before the Committee. As per the representation the candidate was passed BCA from IGNOU whereas as per the eligibility criteria for MCA programme, reproduced above (Case no. 1) there is requirement of minimum three years full-time from a recognized University with Mathematics / Statistics as one of the subjects.

The Committee is of the opinion that the BCA passed by the candidate from IGNOU cannot be considered as Full Time. Hence, he does not fulfill the eligibility criteria for admission to MCA as mentioned in the Admission Brochure 2019-20.

Case 6: The opinion of the Committee was also sought with regard to the two Marksheet issued from the same Board for 10+2 to a candidate who has been allotted seat through Online Counseling in B.Tech programme 2019-20. The Committee taking into consideration para 17 page 11 of Part -A of the Admission Brochure 2019-20 found it eligible for admission to B.Tech programme.

The above recommendations of the Committee subsequently approved by the Competent Authority, GGSIPU for information of the concerned, placed.
