Brahm Prakash Ayurveda Charak Sansthan, Khera Dabar, Najafgarh, New Delhi, affiliated to GGSIP University and display of the list of Registered Applicants for the said course with GGSIP University, inviting discrepancies, if any, and submission of AIAPGET 2019 Admit Card and Score Card copy - reg.

With reference to the subject, cited above, it is brought to the notice of all the concerned/ stake holders, that the 01st round of 50% seats under State/Institutional Quota Counseling for verification of documents and allotment of seats for admission to PG (MD/MS) courses namely (i) Rachna Sharir (ii) Kayachikitsa (iii) Rog Nidan evam Vikriti Vigyan (iv) Panchkarma and (v) Kriya Sharir for the academic session 2019-20, is likely to be conducted tentatively on **11.09.2019** for which a detailed schedule containing all the details shall be uploaded on the University website on **06.09.2019**.

In the mean time, please find attached herewith a list of the candidates/applicants who have registered themselves with Guru Gobind Singh Indraprastha University for admission to PGAC (MD AYUSH) (Code 196). All such candidates/ applicants are requested to kindly go through the attached lists i.e. **List 'A'** containing the names of the candidates who have passed their qualifying degree i.e. BAMS from Ch. Brahm Prakash Ayurveda Charak Sansthan, Khera Dabar, Najafgarh, New Delhi, affiliated to GGSIP University and **List 'B'** which contains the name of all the registered candidates for PGAC course. It is brought to the notice of all the candidates that 50% State Quota seats will be reserved for BAMS graduates of Guru Gobind Singh Indraprastha University. Discrepancy/Correction, if any, in the details submitted by such candidates must be brought into notice on or before 07.09.2019 (upto 04:00 p.m.) at Admissions Branch, Enquiry window of GGSIP University in person. No representation either in person or through email etc. will be entertained after 07.09.2019 (upto 04:00 p.m.) and the candidates will be solely responsible for all the consequences arising out of any error or omission in the tentative list of Registered candidates.

It may be brought to the notice of all the concerned that the University will conduct the counselling only for 50% seats under State Quota for which a candidate must have passed his qualifying degree from the college affiliated with GGSIP University i.e. Ch. Brahm Prakash Ayurveda Charak Sansthan, New Delhi.


Besides, removal of the discrepancies, if any, the candidates must also submit the following documents by 07.09.2019 (upto 04:00 p.m.) at the Admissions Branch, Enquiry window of GGSIP University:

2. Proof of payment of Rs. 1000/- (GGSIPU Registration Fee)
3. Copy of AIAPGET 2019 Admit Card.
4. Copy of AIAPGET 2019 Score/Rank Card.
5. Copy of BAMS degree/provisional certificate.
6. Copy of Internship Completion Certificate.

It is clarified to all the concerned/stake holders that this is the last opportunity for removal of discrepancies/submission of documents and no further period shall be granted beyond the above mentioned period i.e. upto 04:00 p.m. on 07.09.2019.


