## CIRCULAR

The Board of Management, GGSIPU vide Agenda Item No.BM68.09 resolved that "After deliberation the Board Members approved the proposal that the tenure of appointment of Directors of Centres / Departments of Guru Gobind Singh Inraprastha University shall be of three years, which will be at the par with the duration of appointment of Deans. The Board further desired that appointment shall be competitive in nature and will be made by inviting applications from interested senior faculty with relevant qualifications".

In accordance to the Agenda Item No.BM68.09 of BOM, applications are invited for the post of Directors of Centres / Departments of GGSIPU. The interested senior faculty members may submit their application addressed to the Vice Chancellor by 24.06.2019.

Agenda Item No.BM 68.09: To consider and approve the fix tenure of 03 years for the Directors of Centres of Guru Gobind Singh Indraprastha University.

A meeting of Deans of University Schools of Studies and Directors of Centers/Departments of the University was convened on 01.10.2015, under the chairmanship of Hon'ble Vice Chancellor, GGSIP University, wherein the issue regarding tenure of Directors of various Centers/Departments of the University, emerged and after deliberation following was suggested.

"The issue of tenure of the Directors of the Centers was brought up for discussion and it was suggested that the Directors of the Centers should have fixed tenure of 3 years."

It is further informed that in the sub clause (2) of Statute 6 regarding the Deans following has been envisaged:-

"Every Dean shall be appointed by the Vice Chancellor from among the professors of the University for a period of three years and shall be eligible for reappointment."

It is informed that at present there are seven Professors of the University, who have been appointed as Director and looking after various assignment like Center for Pharmaceutical Sciences, Indraprastha University Industry Interaction Cell, International Affairs, Research and Consultancy and Academic Affairs etc. Therefore, it is proposed that tenure of appointment of Director(s) at centers/Departments of the GGSIP University shall be of three years duration, which will be at par with duration of appointment of Deans.

In view of above the matter is placed before Board of Management for consideration and approval that tenure of appointment of Director(s) at centers/Departments of the GGSIP University shall be of three years duration.
