## SECURITY MEASURES DURING "Anugoonj-2019"

The Annual Cultural Festival "Anugoonj-2019" of the University is scheduled to be held from 7th February, 2010 to 9th February, 2019 at University Campus, Dwarka. In this regard, the following Security arrangements have been made, in line with the decisions taken in Security & Discipline Committee for smooth functioning of the Cultura Festival "Anugoonj-2019".

- 1. No student will be allowed in the Campus without proper Photo Identity Card (ID) of the University & Affiliated Institute.
- 2. Student's entry would be allowed from Gate no. 01 (near PRO). They should not carry with them an objectionable things/items like hard/soft drinks/perfume, alcohol, tobacco products, narcotics, any form of weapon, fire arms etc.
- 3. The students will not be allowed to park their vehicle inside the Campus henceforth, they are advised to us public transport to avoid any kind of inconvenience.
- 4. Since large number of students are expected to visit the University Campus, it is requested, If otherwis necessary, the use of vehicles may please be avoided/restricted.
- 5. All the students are under surveillance and they may be frisked by the University Employee for the securit reasons.
- 6. All the students visiting the University Campus for the festival are required to treat the Hostel area an residential flats area as "Out of Bound".
- 7. Personnel engaged from outside agencies for various work during "Anugoonj-2019" should carry their val I-Card otherwise they will not allow to enter the Campus.
- 8. Exit will be allowed from Out Gate of the main gate (no. 02)
- 9. There shall be restricted entry to various Academic blocks during the "Anugoonj-2019". The lifts at other inter-blocks also close during the Fest.
- 10. All the students visiting the Campus are advised to vacate the University Campus within 30 minutes conclusion of events.
