All concerned may please note that this is an opportunity given to the candidates for removal of their discrepancies in their details so filled in their application form. No such opportunity will be given after the above referred date and time.

The University also invites fresh application forms for admission in BHMS programme (Code 154), through Offline mode as per the details given in the succeeding paras of this notification:


