Subject: Non refund of balance amount of fee to students shifted on account of counseling process by few Affiliated Colleges

This is in continuation to University Notification No.183/2020 dated 15.12.2020 vide which the University had issued directions that the Affiliated Institutes shall have to refund the balance fee, if any, paid by the candidate in the Affiliated Institutes before getting Upgraded / transferred to any other Affiliated College / USS through the process of counseling procedure.

It is once again clarified that the candidate who was allotted seat through the counseling process and had reported in the respective allotted colleges after 4<sup>th</sup> Round of Counseling or after the 1<sup>st</sup> Spot Counseling as the case may be, were required to deposit the balance amount of fee in the Affiliated College (other than Rs.40,000/-) to enable the Affiliated College complete the process of online reporting of the candidate. The candidates who had reported as well as deposited the balance amount of fee and were reported online by the Affiliated Colleges / USS were thereafter called as ADMITTED candidates.

The University procedure also had the provisions that these admitted candidates had opportunity to participate in the  $1^{st}$  /  $2^{nd}$  Round of Spot Counseling for allotment of seats in any other Affiliated College / USS for improvement of the preferred choice.

The Admitted candidate who had reported in any Affiliated College thereafter also paid the balance amount of fee (over and above Rs.40,000/- paid through online) and was successful in getting a preferred choice in the 1<sup>st</sup> and 2<sup>nd</sup> Spot Online Counseling were required to report in the new allotted Affiliated College / USS. Such Admitted Candidates who were allotted new colleges had to deposit the balance amount of fee in the new allotted college.

Since the Admitted candidates have paid the balance amount of fee in the new allotted college, thus these candidates are eligible to get refund of balance amount already paid by them in the previously allotted Affiliated College prior to allotment of new Affiliated College.

It is come to notice of the University that few Affiliated Colleges, without any instructions of the University have withheld certain portion of fee paid by the admitted candidate, which is illegal and is in violation of the provisions as well as spirit of the Act "THE DELHI PROFESSIONAL COLLEGES OR INSTITUTIONS (PROHIBITION OF CAPITATION FEE, REGULATION OF ADMISSION, FIXATION OF NON-EXPLOITATIVE FEE AND OTHER MEASURES TO ENSURE EQUITY AND EXCELLENCE) ACT, 2007" (Delhi Act 8 of 2007)

In accordance with the Circular dated 15.12.2020 issued by the University, it is once again notified that the complete fee paid to the college shall be refunded by the Affiliated Institute to the students who have shifted to another college on account of allotment through the counseling process. There will be no amount withheld by the colleges on any account.
