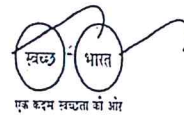

GUIDELINES FOR FOURTEENTH CONVOCATION

All the eligible students are invited for attending convocation in person. They are advised to take note of the following important instructions for necessary information and compliance:

Prior Intimation: The students as per list notified on the University Website, who wish their Degrees (in case of Ph.D. Scholars)/ Certificate of Merit and Gold Medal (in case of Gold Medalists) to be conferred "in person" are required to submit **Consent Letter** as per Annexure- "A" (in case of Ph.D. Scholars)/ Annexure- "B" (in case of Gold Medalists) and Admit Card Performa as per Annexure-"C" (**Two copies**) duly verified by the Dean/Director/Principal of the School/ Institute concerned latest by **27th March, 2022 (01:00 p.m.)** in Examination Division, Guru Gobind Singh Indraprastha University, Dwarka positively, failing which the Degree/Certificate of Merit and Gold Medal would be conferred "**in-absentia**".

Admit Card: The Admit Card will be issued on receipt of consent from the students. **Students without proper 'Admit Card' will NOT be allowed to attend Rehearsal and Convocation.**

Rehearsal: For orderly conduct of Convocation, a rehearsal will be conducted in 'Convocation Pandal' on **29th March, 2022 at 11:00 a.m.** for which students must report at **10:00 a.m.** in the University. **All the Ph.D. Scholars and Gold Medalists must attend this rehearsal, failing which they would not be allowed to attend the Convocation.** The students will attend the rehearsal and occupy their allotted seats strictly as per "Seats Allocation".

Reporting for Convocation: Convocation will be held in 'Convocation Pandal' on **30th March, 2022** for which students must report at the respective "**Attendance Counter**" established in the University on **30th March, 2022 at 08:30 a.m.** and get their seat number in the 'Pandal' allotted.

Convocation Gowns: All the students will be **Compulsorily** wear gowns, which will be available on hire from the "Gown Counters" established in the University on **30th March, 2022 at 09:00 a.m.** The gowns will be issued against deposit of Rs. 500 per gown as Security (refundable). The hire charges @ Rs.50 per gown will be deducted when the gowns are deposited back after the Convocation at the Gown Counter. If the Gowns are not deposited by **04:00 p.m. on 30th March, 2022** full security charges will be forfeited.

General Instructions:

- Only the recipient student is allowed entry. The student should strictly adhere **COVID PROTOCOL**.
- Students are requested not to bring any brief case, bag, camera, mobile phone, any electronic gadgets, matchbox, water bottle and eatables inside the University. Students are advised to make their own arrangements for safe custody of their belongings as the University will find it difficult to arrange the same.
