Dear Sir,

With reference to above referred letters on the subject cited above, I am directed to inform you that Competent Authority of Guru Gobind Singh Indraprastha University has accepted your request for renewal of tri-party agreement for operating Amul Parlour (Kiosk) for a period of 03 (Three) years i.e. from 05.04.2022 to 04.04.2025 in Guru Gobind Singh Indraprastha University, Sector 16 C. Dwarka, New Delhi – 110078.

The terms and conditions are as under:-

- 1. The space for kiosk and sitting has been provided by GGSIPU near girls hostels at a nominal rent of Rs.4000/- (Rs.3500+500 sanitation charges) per month.
- 2. Electricity, water and drainage connection will be provided by the University.
- 3. Electric sub meter is installed by the University for the kiosk and actual electricity used will be payable by M/s. Gujarat Co-operative Milk Marketing Federation Limited on commercial rate of BSES paid by the University.
- 4. No water charges will be levied on to M/s. Gujarat Co-operative Milk Marketing Federation Limited, as per earlier agreement.
- 5. The entire operation of the kiosk shall be manner by the franchisee of M/s. Gujarat Co-operative Milk Marketing Federation Limited and monitored by the company personnel on regular basis.
- 6. A Tri-Party agreement shall also be signed with Authorized Franchisee and M/s. Gujarat Co-operative Milk Marketing Federation Limited for a period of 03 years i.e. from 05.04.2022 to 04.04.2025.
- 7. The sale of Amul products will be on MRP. The list of approved items is enclosed herewith as Annexure-A.
- 8. The schemes offered by M/s. Gujarat Co-operative Milk Marketing Federation Limited during the Festival season will also be given/extended to the University Students and Staff by its franchisee.
- 9. Rates and list of items will be reviewed after completion of one year from the date of tri-party agreement.
- 10.Performance Security of Rs.50,000/- shall be deposited by the franchisee of M/s. Gujarat Co-operative Milk Marketing Federation Limited in the form of Bank FDR/DD in favour of the Registrar, GGSIPU as per earlier Work Award Letter.
- 11. A Non Judicial Stamp Paper of one hundred only be submitted in the University for the Tri Party Agreement within 07 days of receipt of this renewal letter.
