**I) WHO ARE ELIGIBLE FOR SPOT ROUND OF ONLINE COUNSELLING:****ADMITTED CANDIDATES**

1. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- and reported at the allotted college/institute in the notified date & time.

**NOT ADMITTED CANDIDATES**

2. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- but did not report at the allotted college/institute in the notified date & time.
3. A candidate who was allotted a seat in the Online Counselling, paid the requisite Part Academic Fee of Rs. 40,000/- and subsequently withdrawn as per procedure.
4. A candidate who was allotted a seat in the Online Counselling, but did not pay the requisite Part Academic Fee of Rs. 40,000/-.
5. A candidate who has not been allotted any seat in any rounds of the Online Counselling.
6. All the registered candidates who have paid the Application Fee of Rs. 1200/- and the Counseling Participation Fee of Rs. 1000/- but did not fill choices.
7. All 'Not Admitted' candidates.
8. Allotted candidates who had chosen Freeze / Float options

**II) SPOT ROUND PROCEDURE:**

- i) Registration for SPOT Round will be for all CET 2022 qualified candidates/ National Level Test qualified candidates irrespective of his/her registration earlier.
- ii) All the already Registered candidates and registering afresh will be allowed to login after accepting the terms and conditions of SPOT Round.
- iii) **CANDIDATES DESIROUS OF PARTICIPATING IN THE SPOT COUNSELLING MAY ADD / DELETE / MODIFY THEIR CHOICES/PREFERENCES.**
- iv) **The candidates who have reported at the respective College/Institution after seat allocation upto Sliding Round, if participating in the Spot Round are assured that if any of the new preferences filled in the Spot Counseling is not allocated to them, their existing allocation of seat shall be retained and shall not change.**
- v) **The candidates who have reported at their respective School of Studies/Colleges/Institution after seat allocation upto Sliding Round, if participating in the Spot Round and if any of the new preferences filled is allocated to them in the Spot Round of Counseling then, the candidate shall be abide to take the new allocated seat and they will not have any claim on the previous seat.**




**Further Procedure to be followed after declaration of result of Spot Round shall be notified in due course of time.**
