### CIRCULAR

Sub: Regarding Compliance of Covid-19 Appropriate Behaviour

As you are aware that the Covid-19 positive cases have been surging day-by-day and as a responsible citizen, it is our duty to follow covid-19 appropriate behaviour in our daily life to prevent the spread of Covid-19. Therefore, all students, employees and their family members residing in the premises of GGSIP University are advised to follow Covid-19 Appropriate Behaviour strictly i.e. wearing of face mask / cover, maintaining of social distancing etc. as per the latest guidelines issued by the Delhi Disaster Management Authority (copy of order is enclosed herewith).

It is further advised that in case of any symptoms of Covid-19, promptly report to the University Medical Officer / Doctor for investigation. As per the advice of the Medical Officer / Doctor, covid-19 test must be administered and isolate themselves till the report received. If found positive, immediately inform the concerned office and proceed to quarantine as per the advice of the Medical Officer / Doctor.

All students, employees and their family members should strictly adhere to the directions mentioned above. In the event of non-compliance of the above instructions by any employee and their family member, a strict action will be initiated as per the rules.

### ORDER

Whereas, DDMA has issued Order No. 500 dated 28.12.2021 as well as subsequent Order No. 504 dated 04.01.2022, Order No. 509 dated 11.01.2022, Order No. 514 dated 21.01.2022, Order No.515 dated 27.01.2022 and Order No. 518 dated 04.02.2022 with regard to permitted / prohibited / restricted activities in NCT of Delhi;

- 2. And whereas, MHA, Gol vide Order No. 40-3/ 2020-DM-I (A) dated 25.02.2022 has directed the State / UT Governments for re-opening of economic and social activities on risk assessment based approach. Accordingly, COVID-19 situation in Delhi has been reviewed in DDMA meeting held on 25.02.2022 under the Chairmanship of Hon'ble Lt. Governor, Delhi wherein it has been observed that numbers of COVID-19 cases and positivity rate have declined significantly, also the occupancy of beds in hospitals is very low and the situation has vastly improved and therefore it is decided to remove all the restrictions in NCT of Delhi imposed by DDMA.
- 3. Now, therefore, in exercise of powers conferred under section 22 of the Disaster Management Act, 2005, the undersigned, in his capacity as Chairperson, State Executive Committee, DDMA, GNCTD, hereby directs to remove all prohibitions / restrictions imposed vide aforesaid orders of DDMA in the territory of NCT of Delhi w.e.f. intervening night of 27<sup>th</sup> February, 2022 and 28<sup>th</sup> February, 2022 (00:00 hrs) till further orders, except that the blended / hybrid mode (online & offline) of learning and consent from parents is to be followed in respect of students upto class 9<sup>th</sup> as well as for class 11<sup>th</sup> till 31.03.2022 in Schools, Educational / Coaching Institutes, subject to the compliance of SOPs / Guidelines / Orders issued by Gol / NDMA / GNCTD / DDMA etc. from time to time.
- 4. It is, however, emphasized that while allowing all such activities, the wearing of masks, maintaining social distancing, hand hygiene and ventilation in closed spaces, as mandated in National Directives for COVID Management, shall continue to be enforced at all places.
- 5. All District Magistrates, District DCPs and other authorities concerned shall focus on strategic areas of intervention i.e. Containment, Test, Track, Surveillance, Clinical Management, Vaccination as well as strict compliance of CAB in their respective jurisdiction. The authorities concerned shall take strict action against the defaulting persons as per the applicable laws and rules, including closure of defaulting establishments / business premises / weekly markets/ exhibitions / gatherings etc as per requirement.
- 6. Health & Family Welfare Department, GNCTD shall issue necessary orders for reducing fine from Rs. 2000/- to Rs. 500/- per offence in respect of COVID Appropriate

Behaviour related violation (i.e. wearing of face mask/ cover, maintaining of social distancing, prohibition of spitting in public places etc).

7. In case any person is found violating the aforesaid instructions, the defaulting person(s) shall be proceeded against as per the provisions of section 51 to 60 of the Disaster Management Act, 2005, Section 188 of IPC and other applicable laws.

### ORDER

Whereas notification No 52/DGHS/PH-IV/COVID-19/2020/prsecyhfw/13087-336 dated 13.06 2020, as further amended dated 20.11.2020 & 26.02.2022, in respect of The Delhi Epidemic Diseases, (management of COVID-19) Regulations, 2020 was issued.

And whereas, DDMA in its meeting held on 20.04.2022 noted that the positivity rate of COVID-19 infection has been increasing in Delhi over the past fortnight.

And therefore, the DDMA after examining all the relevant facts related to the issue of penal provisions for not adhering to the covid protocol of wearing of mask at public places, decided that, in relation to the clause 3(h) (c) whereby not wearing of face mask/cover in all public places has been made an offence, a fine of Rs. 500/- for not wearing of face mask/cover in all public places in Delhi will be imposed from immediate effect till further orders in compliance of Notification dated 26.02.2022. Further, the fine under this provision of the notification will not be applicable to persons travelling together in private four wheeler vehicles.

This issues with the prior approval of competent authority.
