This is for information that all unaided Institutions (except Minority Institution/ unaided Institution who have surrendered Management Quota) shall admit students in the Management Quota during Academic Session 2022-23 in accordance:

- (a) Provisions of Sub-Section (m) &(n) of Section 3, Section 12 & Section (13) of 'The Delhi Professional Colleges or Institutions (prohibitions of capitation fee regulation of admission, fixation of Non-Exploitative Fee and other measures to ensure equity and excellence) Act, 2007' (Delhi Act 8 of 2007), Govt. of NCT of Delhi.
- (b) Relevant rules as notified by Govt. of NCT of Delhi, Directorate of Higher Education, Delhi vide letter no. DHE-4(15)/2006-07/1846-1608 dated 14.06.2007.

The complete details of candidates who have applied for admission under Management Quota at your Institute and those who have been admitted under Management Quota should be submitted separately as per the format Annexure-'A' and Annexure-'B' respectively, both in hardcopy and softcopy in Ms-Excel.

Kindly submit the list of admitted candidates along with the following documents for ratification and allotment of University's Enrollment No. in the form of hard copy and also send the soft copy of the same through e-mail:

- (a) Affidavit by the Chairman or Secretary of the Society in consonance with the rules notified by the Govt. of NCT of Delhi referred above and following rules as mentioned in Section 8(2) a(i) to (x) of the letter No. DHE-4(15)/2006-07/1546-1605 dated 14.06.2007.
- (b) List of admitted candidates indicating Student Name, Father's Name, Date of Birth, NLT Rank/ CET Rank and percentage of qualifying examination (Aggregate % should be strictly as per eligibility criteria mentioned as per the rules).
- (c) Copy of advertisement of Admission Notice published in at least two leading daily newspapers, one in Hindi and other in English in addition to display of the same on Institution Notice Board etc., as mentioned in the Notification dated 14.06.2007.
- (d) Personal file of the admitted candidates containing Application Form, Admit Card, copy of NLT Rank Card/ CET Rank Card and all other documents as required for admission alongwith supporting documents.
- (e) Payment of Rs. 20,000/- for each of the admitted candidates through Demand Draft in favour of "Registrar, Guru Gobind Singh Indraprastha University" payable at Delhi.

The Colleges/ Institutions admitting candidates in Management Quota shall ensure strict compliance of the provisions of the "The Delhi Professional Colleges or Institutions Act, 2007" and the relevant rules notified by Govt. of NCT of Delhi in the transparent manner.
