
All the Institutes are required to display the Counselling schedule alongwith the Seat Matrix for admission under Management Seats on their Institute's portal.

Important Instructions:

1. The candidates must read the conditions of eligibility as given in the Admission Brochure 2022-23 and other Notifications issued by GGSIP University for admission in B.Tech Programme under Management Quota and must satisfy themselves regarding their eligibility.
2. The candidates seeking admission against the Reserved Category have to produce original Cast Certificate issued by the Competent Authority, Govt. of NCT of Delhi besides the undertaking in the format given in Annexure-10 of the Admission Brochure - 2022-23 at the time of verification of documents.
3. Only candidates with **NOT Admitted Status** are eligible to take part in the Counselling for Management quota. (Not admitted means a candidate who has not taken admission in any of the Institutes affiliated to GGSIPU nor in University Schools of GGSIPU) or admitted under Management Quota. **Original admit card JEE is mandatory.**
4. Candidate shall submit an Affidavit / Undertaking that he/she has not taken admission and will not seek admission anywhere else in any of the College affiliated to GGSIP University once the seat is allotted under Management Quota.

5. Candidate who has already taken admission through online Counselling or under Management Quota in any of the Institutes affiliated to GGSIPU shall not be eligible for consideration of seat allotment under Management Quota.
6. The candidates desiring to participate in the aforesaid Counselling must report at the Institute before the designated time, latecomers will not be allowed.
7. The management Quota seats will be filled up on the merit basis derived from the aggregate percentage scored in the qualifying examination/preference of the course or program opted by the candidate.
8. Seat Matrix for Management Quota Seats for B.Tech Programmes (Code-131) of this Institute is already available on the University Portal.
9. In the inter-se merit of candidates, securing equal aggregating marks in the qualifying examinations criteria laid down in the Admission Brochure-2022-23 of the University shall be applicable.
10. Classes for 1st year students of B.Tech Programmes have already been commenced from 7th November, 2022 as per the Academic Calendar notified by the University vide Ref. No.GGSIPU/DAA/2022/4388 of October 31, 2022.
11. All admissions are provisional subject to the ratification by the University.
12. For further notification/s, applicants are advised to visit regularly the Institute website www.adg.tmdelhi.ac.in.
13. **The candidates shall bring following documents in original along with self-attested copies of their testimonials for verification/deposition in the Institute.**
 - (i) Proof of registration/application submitted for Management Quota Seat applied on GGSIP University Portal/Institute.
 - (ii) JEE Main Paper-1 of 2022 Admit Card (Original & Photocopy)
 - (iii) Copy of Rank obtained in JEE Main Paper-1 of 2022.
 - (iv) Original Certificates and Mark sheets of qualifying examination along with two sets of self-attested photocopies.
 - (v) Reserved category candidates shall bring original reserved category certificates along with two sets of self attested photocopies.
 - (vi) Physical Fitness Certificate. All students shall be required to submit a Medical Certificate as given in Part-8 in Admission Brochure-2022 (As per Appendix-5).
 - (vii) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer (Original), not more than 6 (six) months old.
 - (viii) Six Recent Photographs (Size 1.5 Inch X 2 Inch) In Coloured Showing Front View of Full Face with White Background is Required (Black & White Photograph with Colour or Dark Glasses Dark Background, Polaroid Prints or Computer Prints will Not Be Accepted).
 - (ix) Copy of Aadhar and PAN Card
 - (x) In case of gap year, the candidate is also required to submit a notarized Gap Year Affidavit on Stamp Paper of Rupees Ten along with one self-attested photocopy.
