- All previous choices shall be treated as null and void. Candidates desirous of participating in the SPOT counselling shall have to fill new choices/preferences.
- The candidates who have reported at their respective School of Studies/Colleges/Institution after seat allocation upto Sliding Round, if participating in the Spot Round are assured that if any of the new preferences filled in the Spot Counseling is not allocated to them, their existing allocation of seat shall be retained and shall not change.

**\*\* Adjustment of Part Academic Fee in SPOT ROUND of Online Counselling:**

All CAT 2021 qualified candidates who have been allotted seat in the previous rounds of Online Counselling and had paid the Part Academic Fee of Rs. 40,000/- and wish to participate in the Spot Round of Counseling, their part Academic Fee of Rs. 40,000/- (Rupees Forty Thousand only) paid in the earlier rounds of Online Counselling will be adjusted during the Spot Round of Online Counselling. Such candidates, if allotted a seat in the SPOT ROUND of Online Counselling need not pay the Part Academic Fee of Rs. 40,000/- again.

The following candidates need not to pay again the Part Academic Fee of Rs. 40,000/- (Rupees Forty Thousand Only) during admission in SPOT ROUND of Online Counselling (i.e. if a seat is allotted in the Spot Round of Counselling):

- A candidate, who was allotted a seat in any round of Online Counselling and paid the Part Academic Fee and Reported.
- A candidate, who was allotted seat in online round of Online Counselling, paid the Part Academic Fee but did not report in the allotted institute.
- Any candidate, who was admitted in any round of Online Counselling, paid the Part Academic Fee and subsequently withdrawn as per procedure.

**VIII) Choice Filling :**

- Choice filling is compulsory for allotment of seat. Candidate will not be considered for online allotment of seat without the filled in choices/preferences.
- After registration, candidate has to fill choices for allotment, from the list of all possible combinations of all institutes and courses available, in the order of his/her preference, during the choice filling period.
- Once the period for filling of choices/preferences is over, choices/preferences filled by candidate will be used for allotment of seat.
- Candidates are advised and encouraged in their own interest to fill maximum number of choices, as it increases the possibility of getting the desirable seat. For the benefit of the candidates, the stream wise and institute-wise and rank-wise Admission Rank cut off data is available on University Website and as relevant link in <https://ipu.admissions.nic.in>.
- From previous experiences, it has been noted that some candidates fill up very few / limited number of choices, may result in non allotment of seat during seat allotment. Therefore it is once again advised that the candidates should fill as many choices as possible to ensure that they have better chances of allotment of seat.
- Candidates, however, will be given the opportunity to edit/modify/add/delete preferences after allotment of seat in Round 01 for the subsequent round of counselling.
- The candidates are also advised to fill choices/preferences, then save the same and then take the print out of the saved choices/preferences to be retained for future reference.

**IX) Freeze / Float of Allotted Seat after every Round of Counselling:**

- After every round of Counselling, if the candidate is satisfied with the seat allotted to him and does not want to participate in subsequent rounds of counselling for upgradation, he/she can freeze his/her allotted

- b) If the candidate wants to upgrade his/ her choice by participating in next round of counseling as per his/ her filled choices should choose option Float.
- c) Those candidates who opt „FLOAT“ option will be able to participate in next round of counselling and his/ her allotted seat will get retained if the candidate is not able to get higher choice.

**X) Withdrawal and Fee Refund after online Rounds of Counselling :**

- a) After depositing of Academic Fees, if a candidate wants to withdraw the admission against the allotted seat, he/she can apply for withdrawal by clicking on the withdrawal option available in his/her account in the admission website within the specified time period, following the online withdrawal procedure.
- b) All candidates who have withdrawn, frozen their seat, not paid the Part Academic Fee of Rs. 40,000/- and who do not fulfill the eligibility criteria, will not be participating in the subsequent round of online counselling and the vacancies with respect to such candidates will be considered for allotment of seat in subsequent Rounds.

**XI) Reporting of candidates to the allotted institute/college:**

- i) After declaration of result of SPOT Round of Online Counselling, the candidates allotted seat, have to report to the allocated University School/Institutions for verification of documents and payment of balance Part Academic Fee as per the Offer letter of result of Spot Round of Online Counselling.
- ii) After allotment of seat in the Spot Round of Counselling, the candidate, if allotted a seat/retained the seat from earlier allotment/upgraded to higher choices/preferences, and if he/she has made the payment of Part Academic Fee of Rs. 40,000/- (if not paid earlier), can generate Provisional Admission Slip.
- iii) Proof of payment of Part Academic Fee receipt of Rs. 40,000/- is available in the candidate's profile.
- iv) The candidates are required to report and join the respective School/College with the Provisional Allotment Letter and the necessary record for verification of documents at the School/institution/college and pay the balance amount of fees (if any), as per the schedule notified on the website, failing which the admission shall be automatically cancelled.

g) **Physical Fitness Certificate:**

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-E in Admission Brochure 2022-23 (As per Appendix 5).

h) **Copy of Online Reserved Categories verification slip.**

i) **Reserved Category Certificate:** All reservation category candidates who are seeking admission in reserved category in SC / ST / DEF / PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. The Defence Category/ARMY Category candidates, in addition to all the documents, shall also bring relevant Appendix duly completed. The appendices are available in Part E of Admission Brochure 2022-23.

j) **Conduct and Character Certificate** in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.

k) **Application regarding age or any other relaxation with necessary approval (if necessary).**

l) **The required Certificate(s) for reserved categories / classes will be essential at the time of the counselling / admission and no provisional admission shall be admissible for want of caste/category certificate from the local competent authority. Further, the caste / category certificate should invariably be in the name of the candidate himself / herself and not in favour of respective parents / guardians.**

m) **Proof of payment of Part Academic Fee** Payment receipt of Rs.40,000/- will be available in candidates profile.

**Important Note:-**

a) **Admitted Candidates who are allotted an upgraded seat in the Spot Round of Counselling needs to pay an additional amount of Rs. 5000/- at the newly allotted University School/Affiliated College.**

b) **The upgraded candidates have to pay the balance amount of fees (if any), at the newly allotted college/institute/University School. The balance fee paid by such candidates in their previously allotted/reported college/institute shall be refunded to them by the respective college/institute with immediate effect.**

c) **In Affiliated Colleges/Institutes of GGSIPU:** The balance amount of fees may be submitted through both Online (Net Banking/ Credit Card/ Debit Card) and Offline (through Demand Draft) as per the instructions issued by the respective Affiliated College/Institute.

d) **The Dean/Director/Principal will be responsible to ensure that the eligibility of all the students are checked by them to ensure correctness of admission specially in case of provisionally admitted students.**

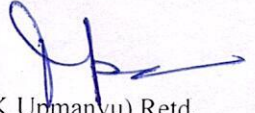

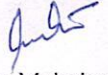
