(CSE/IT/ECE/VLSI/R&A) shall report in person for Extended Open House Counselling for 'Verification of Documents' and 'Allotment of Seats', at the venue of Counselling; on the date and time mentioned below, as per their Category and Rank.

2. The next preference in the merit list will be given to NON-GATE candidates based on rank obtained in the CET.
3. Allotment of Seat will stop as and when the seats get filled up.
4. The counseling will be subject to availability of vacant seats if any and in any category.

3. **Reservation Policy**

Candidates shall please refer to the Chapter 6 : 'Reservation Policy', Part-A, Admission Brochure 2022-23 and as notification issued by the GGSIP University from time to time in this regard.

4. **Eligibility Criteria for Programme M.Tech. (CSE/IT/ECE/VLSI/R&A) CET Code-139,140,156**

Minimum 60% or equivalent in the qualifying examination as under:-

1. B.Tech. / B.E. in Computer Science/Computer Science & Engineering / Computer Engineering / Information Technology /Electronics and Communication Engineering /Electronics & Instrumentation Engineering / Instrumentation & Control Engineering/ Electrical Engineering/Electrical & Electronics Engineering or equivalent.
2. Grad. IETE/AMIE (ECE/CSE/IT/EE).
3. M.Sc. (IT/ Electronics/ Computer Science/Informatics/ Information Science & Technology/ Physics/ Mathematics/ Statistics/ Operation Research/Applied Physics).
4. MCA or MCA (SE)

5. **Documents Required for Verification and Allotment of Seats:**

- a) Bank Draft(s) of **Rs. 1,33,000/- (Including Rs. 1,000/- Counseling Processing Fee (one time non-refundable))** in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, phone, address, mobile no., name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s). Balance fee has to be paid at their respective Institute/College.
- b) Four passport sized photographs (same as that in admit card)
- c) Qualified and Valid GATE Score Card (Original), if applicable.
- d) Experience Certificate (original), if applicable.
- e) CET-2022 Admit Card in Original and CET - 2022 Result

- Copy of Admission verification form (Copy of Admission verification form as per Appendix 4A in Part E of Admission Brochure 2022-23.)
- g) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- h) Mark-sheets / Certificates of qualifying examination:
The candidate will be required to bring the Original certificates / Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates / Mark-sheets of qualifying examination.
- i) Physical Fitness Certificate:
All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-E in Admission Brochure 2022-23 (As per Appendix 6).
- j) Reserved Category Certificate:
All reservation category candidates who are seeking admission in reserved category in UR&EWS/ SC / ST / DEF / PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. The Defence Category candidates, in addition, shall also bring Appendix 1 duly completed. The Appendices are available in Part E of Admission Brochure 2022-23.
- k) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- l) Application regarding age or any other relaxation with necessary approval (if necessary).
- m) The candidate claiming reservation against UR&EWS category must produce certificate issued by the Competent Authority at the time of verification of documents and allotment of seat.
6. **Instructions to be followed at the time of Extended Open House Counseling 2022-23:-**
- a) The students, who have been admitted during 1st, 2nd & Open house counseling in any category, will not be allowed to change their category in Extended open House Counselling.
- b) ~~The Extended Open House Counselling will commence from rank one onwards for all categories / programmes and the seats will be allotted strictly on the basis of merit of the candidates. Such candidates, who were absent in the First, Second & Open House Counselling will also be permitted to attend the Extended Open House Counselling.~~
- c) The students who take admission in first, second and open house counselling would be allowed to exercise the option to change the programmes/ institute in the Extended Open House Counselling within the ambit of the programmes/ institutions included in the specific CET Code after depositing an additional sum of Rs. 5000/- in the form of a fresh Demand Draft in favour of Registrar, Guru Gobind Singh Indraprastha University

payable at Delhi. However, this change of programme/ institute will be allowed only if the candidate reports on the scheduled venue, date and time. If he/she does not report on the scheduled venue, date and time, then the right of change of programme/institute shall be forfeited and he/she will not be allowed to exercise this option for which the University will not be responsible. No change shall, however, be permitted for a programme for which a separate Entrance Test has been conducted by the University. Category change will also not be allowed in Extended Open House Counseling.

- d) A candidate who fails to appear in person on the notified date and time for counselling, shall forfeit his/her claim for the seat which could be offered to him/her, had he/she been present on his/her turn. However, if the candidate reports late or reports on subsequent days during the process of counselling, he/she may be considered for allotment of a seat available at that point of time provided he/she had not taken admission earlier.


7. **Seat Matrix:** To be displayed at the time of counselling.
