In this connection, the aforesaid case has been examined, accordingly, revised result of USCT has been prepared which is strictly based on the University School-Wise/Institution-wise/Shift-wise. Common merit list of the students (without making any branch-wise differentiation) prepared on the basis of average SGPA (SEMESTER GRADE POINT AVERAGE) obtained by the student in the First Semester Examinations conducted by the University.

In case of tie between two or more students, the following procedure has been followed to break tie and decide merit for the upgradation of the student.

- The student with highest sum of product of marks obtained in each paper and credit assigned to each paper will rank higher.
- In case tie is not resolved by (A), then the student with highest marks obtained divided by total maximum marks will rank higher.
- In case tie is not resolved by (B), then the student with highest marks in theory paper or component will rank higher.
- In case tie is not resolved by (C), then the student "older in age" will rank higher.
