

GUIDELINES FOR OUTSTANDING RESEARCHER AWARDS

1.0 Introduction

Guru Gobind Singh Indraprastha University strives for excellence in research and achieve national and international recognition for its research output in different fields. With this goal, the University has established the "Outstanding Researcher Awards" to incentivize quality publications, patents, extramural grants and other accomplishments /achievements of its faculty members in the form of impactful quality research. Such incentives will further stimulate and invigorate the research and innovation activities of the GGS Indraprastha University.

2.0 **Objectives**

- > To inspire faculty members for carrying out quality basic, applied and translational research in different fields
- > To motivate faculty members for undertaking extramural projects from different funding agencies/bodies
- > To motivate faculty members for publication of quality research papers
- > To encourage faculty members to collaborate for interdisciplinary and trans disciplinary research projects & consultancy projects
- To stimulate faculty members for capturing, securing and licensing IPRs
- To encourage faculty members to initiate & nurture start-ups individually or in partnership

3.0 Eligibility

- The faculty members in the regular employment of the University in University School of Studies (USS) or Centre(s) of Excellence established under Ordinance 35 of the University (CoE) shall only be eligible for the award in recognition of their Research achievements (including those on probation).
- 3.2 The faculty members on deputation to the University or associated with the University as adjunct faculty or employed with the University on tenure/contractual basis shall be eligible to apply for the award in recognition of their research achievement, if their research output pertains to the work done in GGSIPU and identifies their association with the University.

4.0 Selection Criteria

4.1. The Outstanding Researcher Awards shall be presented to faculty members based on the criteria

4.2 Collaborative Research Activities

- Collaboration in case of research publications, extra mural research projects, consultancy, patents, will have the following bonus points: 5 credit points for National Collaborations, 07 credit points for International Collaborations and 09 credit points for Industry Collaborations.
- . Bonus points will be given only if the faculty of GGSIPU is either the first or

corresponding author in the research publications.

Collaborations in research publications, Extra-mural research grants, consultancy or patent /IPR with a relative of the faculty of GGSIPU shall not be considered for bonus points for collaborative research.

5.0 Assessment Period

The Outstanding Researcher Awards shall be conferred annually in each School/Centre. The calendar year shall be the period for calculating the points earned by the faculty members, i.e. period from 1st January to the 31st December of the preceding year.

6.0 Application Procedure

- Call for applications will be notified by the office of Director, Research and Development Cell every year.
- Eligible faculty members shall submit their completed application in the prescribed format (Annexure 1) along with all supporting documents to the office of the Dean of the concerned USS/Director of the concerned Centre, who shall get the applications screened by the SRC/CRCC or its subcommittee of the concerned USS/Centre in accordance with these guidelines.
- The Dean of the concerned USS/Director of the concerned Centre shall forward the applications to the office of the office of Director, Research and Development Cell after recording the credit points awarded in each selection criteria by the SRC/CRCC Subcommittee of SRC of the concerned USS/Centre.

7.0 Screening Committee and Award Selection Committee

- 7.1 The applications submitted by the faculty members for the Outstanding Researcher Awards will be screened and evaluated by the SRC/Subcommittee of SRC of concerned USS / Centers for the points claimed by the faculty in accordance with these guidelines.
- 7.2 A five member Award Selection Committee shall be constituted by the Vice-Chancellor with Director, Research & Development Cell, Director, Academic Affairs, Member Secretary, IIQAC and any two Deans of USS as the members of the committee. The two Deans of USS will be nominated by the Vice-Chancellor. The decision of the committee shall be final and binding.
- 7.3 The Award Selection Committee shall decide the minimum threshold credit points every year for each USS/Centre based on the applications received & such that atleast 10% of the total applicants of the

concerned USS/Centre qualify. All such faculty members shall be felicitated with a certificate of appreciation.

7.4 All faculty members scoring above the minimum threshold credit points shall be eligible for receiving the Outstanding Researcher Awards in three different categories, A, B and C, based on the credit points scored by them. However, there should be a minimum of 10 credit points scored each from any three research activities listed in table 1. The Award Selection Committee shall decide the credit points for each of the three categories based on the applications received in a particular assessment year. All faculty members who score these credit points shall receive a certificate of appreciation & a cash reward.

8.0 General Conditions

- 8.1 Applicants of the award shall have to submit the completed form in soft copy & hard copy along with supporting documents to the office of RDC duly forwarded by the Dean of concerned USS.
- 8.2 Incomplete applications shall not be considered.
- 8.3 A faculty member shall be considered for the award in only one of the above three categories in a given assessment year
- 8.4 These guidelines are subject to review and may be changed from time to time.
- 8.5 Notwithstanding anything contained in these guidelines, for any unforeseen issues arising not covered under these guidelines, or in the event of differences of interpretation, the Vice Chancellor is authorized to take a decision in consultation with the Award Selection Committee. The decision of the Vice Chancellor shall be final.
