**IMPORTANT NOTIFICATION REGARDING CONDUCT OF LAST AND FINAL ROUND OF COUNSELLING (ON THE BASIS OF SCORE / MERIT OF CUET ONLY) FOR BCA, BBA / 5 YR BBA MBA INTEGRATED, BACHELOR OF COMMERCE (HONOURS), BA (JMC), BA LLB- BBA LLB, BA (ECONOMICS), BA (ENGLISH), MBA, B.Ed. and MCA PROGRAMMES.**

**THIS LAST AND FINAL ROUND OF COUNSELLING BEING HELD IN VIEW OF VACANCIES ARISING IN VIEW OF WITHDRAWALS BY THE CANDIDATES FROM VARIOUS COLLEGES & FEW SEATS NOT FILLED UP DURING PREVIOUS ROUNDS OF COUNSELLING.**


**THE CONDUCT OF THIS ROUND OF COUNSELING IS TO FACILITATE ONLY THOSE CANDIDATES WHO HAVE NOT BEEN ABLE TO GET ADMISSION FOR CERTAIN REASONS SO FAR.**

1. It is to inform all the stakeholders that the University plans to conduct LAST AND FINAL ROUND of OFFLINE COUNSELLING on the basis of Score of CUET only for the following programmes :-

  3. Bachelor of Commerce (Honours) (Code 146)
  4. BA (JMC) (Code 126)
  5. BA LLB-BBA LLB (Code 121)
  6. BA (Economics) (Code 197)
  7. BA (English) (Code 184)
  8. MBA (Code 101)
  9. B.Ed (Code 122)
  10. MCA (Code 105)
2. It is informed that as per the Judgment of Hon'ble High Court of Delhi in the matter of W.P(C) 401/2023 titled "Shreyansh Sharma vs GGSIPU and others" and Order dated 01.10.2024 in the matter W.P (C) 12285/2024 & CM APPL. 51101/2024 titled Dhruv Jain and Ors vs GOVT of Delhi and Ors, the seats can be allocated to new candidates after applying concept of Capping, so that, NO RANK VIOLATION occurs.
3. **WHO IS NOT ELIGIBLE TO PARTICIPATE IN THIS ROUND OF COUNSELLING**
  - (i) Candidates having 'ADMITTED' status at the end of Spot Round 2
  - (ii) Candidates 'ALLOTTED' seats in SPECIAL ROUND OF OFFLINE COUNSELLING
  - (iii) Candidates 'ALLOTTED' seats in EXTENDED SPECIAL ROUND OF OFFLINE COUNSELLING
  - (iv) Candidates 'ALLOTTED' seats in MOP-UP Round of OFFLINE COUNSELLING (wherever conducted).
  - (v) Candidates who have already taken admission in the Management Quota

Note : Candidates will be required to submit an Undertaking in this regard.



The detailed Schedule for Offline Registration, Verification of Documents (for determination of Merit) and Allotment of Seats alongwith College-wise vacancy status and applicable Capping of CUET Score will be notified on the University Website by 11.10.2024. The detailed Schedule will contain the Important Dates, Fee to be paid at the time of Registration, Fee to be paid at the time of Allotment of Seats, documents required at the time of Registration, documents required at the time of Allotment of Seats etc
5. The details relating to applicability of Domain Specific Subjects / Optional Languages / General Test etc, Online Registration etc for admission to the above programmes from Admission Brochure and University Notification No 252 /2024 F.No. IPU-7/CUET(UG)/Academic/2024/936 dated 23.08.2024 and 253 /2024 F.No. IPU-7/CUET/Academic/2024/937 dated 23.08.2024 may be referred (copy enclosed).
6. Any Candidate, who had "Admitted" status at the end of Spot Round 2; "Allotted" seats in "Special Round of Offline Counselling"; "Extended Special Round of Offline Counselling" and "Mop-up Round of Counselling" (wherever applicable), IF WITHDRAWN, WILL NOT BE ELIGIBLE TO PARTICIPATE in this round of Counselling.
7. For the Assessment of vacancy position, the withdrawals received by 4.10.2024 in the University shall be taken into consideration. Withdrawal applications received thereafter will not be taken into consideration for the purpose of vacancy position.
