**Sub: Entry & Parking Instructions for celebration of "The Silver Jubilee Culmination and Foundation Day" on 12<sup>th</sup> & 13<sup>th</sup> December, 2024**

The Culmination of Silver Jubilee and Foundation Day is scheduled to be held on 12<sup>th</sup> & 13<sup>th</sup> December, 2024 in the University Dwarka Campus.

1. In order to ensure smooth entry & exit in the campus all concerned are requested to comply with the following instructions:-

Gate No. 02 (Main Gate)	Reserved for Entry & Exit of VVIP, VIP, Faculty / Officers / Staff of University & Official / Staff of Affiliated Institution / College.
Gate No. 04 (Near Badminton Court)	Entry & Exit of Students, Residents & Hostellers

2. The parking arrangements for Vehicles has been earmarked as under:-

(a) For VVIP	D & E Block Parking Area
(b) For VIP	Parking Near Basketball Court
(c) For Faculty / Officers / Staff of University	Block A, B, C & Opposite PRO Office Parking Area, Near Indian Bank Parking Area
(d) Official / Staff of Affiliated Institutions	Parking near Auditorium or outside Gate No. 04
(e) Students & Outsourced Staff	Parking Outside Gate No. 04

3. Vehicles of Students shall not be allowed inside the University Campus, therefore they may use public transport to avoid any kind of inconvenience.
4. Entry of other vehicles (Except above) shall not be allowed inside the University Campus.
5. All Invitees are requested to bring their Invitation Card / Identity Card.
6. All Outsourced Staff would be allowed in the University Campus who have valid identity Card. All outsourced staff are requested to park their Vehicles outside Gate No. 04 due to Security arrangements.
7. All the Residents and Hostellers are advised to use Gate No. 04 (near Badminton Court) for entry & exit and also convey to the drivers of School Bus / Van to use Gate No. 04 to pick-up & drop of their wards to / from School. No outside delivery boys are allowed on 12.12.2024 from 08:00 AM to 2:00 PM, thereafter the entry of delivery boys will be allowed from Gate No. 04 only due to security reasons. Sh. Kamlesh (Security Guard) shall be deployed at Gate No. 04 who can be contacted at Mobile No. – 9828917110 in case of emergency.
8. It is also requested to Faculty / Officers / Staff of the University to use public transport (if possible) to avoid any kind of inconvenience.
9. All the Faculties / Officers / Officials of the University are advised to carry their Identity Card (ID) with them.
10. Entry in the Venue / Pandal shall be allowed only to those who possess necessary valid Identity Card / Invitation Card.


