Applications are invited for admission to AICTE Approved two year M.Tech in Artificial Intelligence and Data Science programme offered at Centre for Development of Advanced Computing, Noida (C-DAC, Noida), a scientific society of Ministry of Electronics and IT, Govt. of India.

### Eligibility criteria:

Minimum 60% or equivalent in the qualifying examination as under:-

- 1. B.Tech. / B.E. in Computer Science/Computer Science & Engineering / Computer Engineering / Information Technology /Electronics and Communication Engineering /Electronics & Instrumentation Engineering / Instrumentation & Control Engineering/ Electrical Engineering/Electrical & Electronics Engineering or equivalent.
- 2. Graduate IETE/AMIE (ECE/CSE/IT/EE).
- 3. M.Sc. (IT/ Electronics/ Computer Science/Informatics/ Information Science & Technology/ Physics/ Mathematics/ Statistics/ Operation Research/Applied Physics).
- 4. MCA or MCA (SE).

### Admission Criteria:

- 1. GATE qualified applicants will get first preference -the candidate should have qualified in the relevant discipline (CS, EC, EE, IN, MA, PH, ST) with a valid GATE score card.
- 2. Non-GATE Candidates will be shortlisted on the basis of a merit list prepared by the University based on the average percentage in the qualifying degree.

The reservation certificate should be issued from the respective state/region in which the reservation is claimed e.g. in case any candidate claims for the seat reserved for DSC category then he has to bring SC certificate issued by Govt. of NCT of Delhi and also passed his/her qualifying exam from Delhi.
- Conduct and Character Certificate from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer/Notary Public.
- 7. Certificate of Medical Fitness to be signed by a Registered Medical Practitioner holding a degree not lower than MBBS in the format as given in Appendix; 5 (Original) http://www.ipu.uc.in/ Pubinfo2022/ 240323330%20(1).pdf

#### Note:-

- (a) The Original Certificates (except the medical certificate & Character certificate) will be returned to the candidates after verification.
- (b) In case if any of the above document(s) is/are in any language other than Hindi/English, then authentic translation in English/Hindi shall have to be produced duly verified by the issuing institution/gazetted officer(original and photocopy) by the candidate at the time of Counselling/Admission. Failure on the part of candidate to produce the requisite authentic translation may result in refusal of admission by the Admission Officer, for which only the candidate will be responsible.
- (c) In case the Degree/certificate has been obtained from some University of any other country then an equivalence certificate must be obtained from Association of Indian universities prior to attending the counselling.
- (d) The required certificate(s) for reserved categories/classes will be essential at the time of the counselling/admission and no provisional admission shall be admissible for want of caste/ category certificate from the local competent authority. Further, the caste/ category certificate should invariably be in the name of candidate himself/herself and not in favour of respective parents/ guardians.
- (e) In case of married woman applying under reserved category, she has to produce the caste certificate in the name of herself. Certificate in the name of husband/mother/father is not acceptable.
- (f) The candidates who have passed the qualifying examination through Distance/Open Education system of any recognized University/Board and fails to provide the proof of his/her study center being located in Delhi shall not be considered for Delhi region Seats, and shall be considered for admission in the Outside Delhi Region. The proof of Study Center has to be from the Graduating university certifying that study center is their approved Study Center.

- 8. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of Counselling/allotment of seats, candidate should ensure that he/she fulfills all eligibility conditions as laid down in the respective Admission Brochure for the session 2023-24. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and disciplinary action will be initiated against him/her and entire fee will also be forfeited.
- 9. Admission will be made strictly on merit basis (Rank-wise) and counselling/admissions will stop when all the seats get filled-up for the particular round.
- 10. The candidates are also advised, in their own interest to check the details of fee, their name, rank, programme, etc. on Admission Slip issued to him/her by the Admission Officer before leaving the counselling hall.
- 11. Withdrawal of Admission: All the withdrawal applications shall be processed in accordance with the Refund Policy 2023-24, as notified in Part-C (Chapter-12) of Admission Brochure 2023-24. The same is available on university website: www.ipu.ac.in. Such candidates should submit filled in Withdrawal form to the office of Dean, USAR(Ground Floor, D Block) by 5:00 PM (IST), Thursday, 26 October 2023.

No application for withdrawal would be accepted after the last date of withdrawal.
