Allotment of Seats

- The allotment of seats shall be carried out irrespective of Region and Category (i) on All India basis.
- It will be the sole responsibility of the candidate to ascertain and make sure that (ii) he/she possesses requisite eligibility and qualifications prescribed for admission in various programmes.
- 2. Eligibility Criteria for Programme- M.Pharm, CET Code-189
- (a) Passed B. Pharm. Degree examination of an Indian University established by law in India from an institution approved by Pharmacy Council of India and has scored not less that 55% of the maximum marks (Aggregate of II, III and IV yrs/ or III to VII semesters of B. Pharm.)
- (b) As per notification of PCI, every student, selected for admission to post graduate pharmacy program in any University (any PCI approved institution) should have obtained registration with the State Pharmacy Council or should apply for the registration of the same within one month from the date of his/her admission, failing which the admission of the candidate shall be cancelled.

Admission Criteria for Programme M.Pharm CET Code-189

The admission to the M.Pharm Programme will be offered on the basis of merit of GPAT qualified candidates. If sufficient numbers of GPAT qualified candidates are not available, admission will be subsequently offered on the merit prepared on the percentage obtained in B.Pharm, list is uploaded on the University website.

Eligibility Criteria for Programme- D. Pharm, CET Code-190

a) To pursue D. Pharma. Course one must have passed the 10+2 examination or equivalent with a minimum of 50% aggregate marks in Science stream PCB or PCM (Chemistry, Physics, Biology or Mathematics).

b) The minimum age to pursue the D. Pharmacy eligibility is minimum 17 years as on date 31.12.2024 and the candidates must possess valid certificates of passing an examination and relevant qualifying examination to get enrolled in D. Pharmacy.

c) Admission in D. Pharmacy would be on merit basis of the marks obtained in the qualifying examination.

Admission Criteria for Programme D.Pharm CET Code-190

Admission shall be given on the basis of merit. Merit list is uploaded on the University website.

(c) Offline Counselling Procedure

Candidates shall please refer to the Chapter 8: 'Offline Counselling Procedure' Part-A, Admission Brochure 2024-25.

(d) Fee to be paid at the time of allotment of seat:

Bank Draft(s) of Rs. 1,55,500/- (for M.Pharm Programme) & Rs. 65,500/- (for D.Pharm Programme) is required at the time counselling in favour of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme, Rank on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted institute.

DOCUMENTS REQUIRED AT THE TIME OF VERIFICATION OF DOCUMENTS & ALLOTMENT OF SEAT

- a) The candidate will be required to bring the Original certificates/Mark-sheets along with photocopy of certificate/Mark-sheets of qualifying examination. (Self attested)
- b) Proof of date of birth (Secondary school, mark-sheet & certificate) (Original and Photocopy) (Self attested)
- c) Mark-sheets/Certificates of qualifying examination. (Self attested)
- d) Physical Fitness Certificate: All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2024-25 (As per Appendix 5).
- e) Character Certificate in Original
- f) Copy of reserved category certificate, if any.



(e) It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2024-25.

If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.
