**Eligibility Criteria for Programme M.Tech (Industrial Biotechnology)**

Candidates are required to have a B.Tech. (Biotechnology/Chemical Engg/ Biochemical Engg/or related field), B. Pharma or MSc (in Biotechnology/Biochemistry or related field of life and natural sciences) with a minimum of 60% (General, EWS & OBC category) or 55% (SC,ST & PwD) marks.

**Documents Required for Verification and Allotment of Seats:**

- a) Bank Draft(s) of Rs. 57,000/- in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi.

Break up of fees:

Tuition (per annum): Rs. 25,000/-

University's charges (per annum): Rs. 20,000/-

Alumni contribution (one time, non refundable): Rs. 2,000/-

Security Deposit (one time, refundable): Rs. 10,000/-

The candidate will write his/her name, date of admission, phone, address, mobile no., name of the programme, GAT-B Score/Rank and GAT-B Roll Number on the back of the Bank Draft(s).

- b) Four passport sized photographs (same as that in admit card)  
c) Qualified and Valid GAT-B Score Card (Original and Photocopy).  
d) Experience Certificate (original), if applicable.  
e) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)  
f) Mark-sheets / Certificates of qualifying examination:

The candidate will be required to bring the Original certificates / Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates / Mark-sheets of qualifying examination.

- g) Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2023-24 (As per Appendix 5).

- h). Reserved Category Certificate:

All reservation category candidates who are seeking admission in reserved category in UR&EWS/SC/ST/OBC-NCL/PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category.

- i). Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.  
j). Application regarding age or any other relaxation with necessary approval (if necessary).  
k). The candidate claiming reservation against UR&EWS category must produce certificate issued by the Competent Authority at the time of verification of documents and allotment of seat
