Counselling for Allotment of seats was conducted by GGSIP University at the given below affiliated institutes in MBBS Programme during the Academic Year 2022-23:

MBBS:

- (i) North DMC Medical College & Hindu Rao Hospital – NDMC (MC), Hindu Rao Hospital, Malkaganj, New Delhi (Admissions to be made against 85% State Quota seats only in respect of candidates who have completed their 11th & 12th class from any school located in the NCT of Delhi).
- (ii) Dr. Baba Saheb Ambedkar Medical College and Hospital, Sector 6, Rohini, Delhi (Admissions to be made against 85% State Quota seats only in respect of candidates who have completed their 11th & 12th class from any school located in the NCT of Delhi)
- (iii) Army College of Medical Sciences, Near Base Hospital, Delhi Cantt., New Delhi (Admissions to be made against 100% sanctioned intake). The admission to the ACMS i.e. Army College of Medical Sciences, is for the children of eligible serving Army personnel, Ex Army personnel and war widows/widows of the Army. The children of categories of Army personnel as detailed in chapter 7.1.4 of the Admission Brochure 2022-23 are eligible and they are required to upload the relevant certificate *Appendix 9 (A), 9(B), 9(C)* as given against the category applicable to them as proof of their eligibility for admission to ACMS.

Para 3 of clause 7.1.4 of chapter 7 of Admission Brochure 2023-24 clearly states that Children of Air Force, Navy and Paramilitary forces like CRPF, BSF, ITBP, CISF, Assam Rifles, GREF and DSC are not eligible for the admission in ACMS against the seats reserved for wards / widows of the army personnel's.

There is no seat reserved in Defence Category for non-army ward/widows seats in Army College of Medical Sciences (ACMS). The para 5 of clause 7.1.4 of Chapter 7 of Admission Brochure 2023-24 is applicable only to the affiliated medical institutes of GGSIP University other than ACMS.

Note: All the concerned applicants/stake holders are hereby informed that the admission of 100% seats in MBBS program at VMMC & Safdarjung Hospital, New Delhi and ABVIMS, Dr. RML Hospital, are conducted by the Medical Counselling Committee, DGHS. - (a) The candidate seeking admission under reserved categories have to mandatorily upload the entitled supporting certificate in his/her name. The Candidates for further details must read Chapter 6 (Reservation Policy) of respective Admission Brochure 2023-24.
- (b) In case the candidate is claiming the seat reserved for DSC/DST/DOBC (wherever applicable) category then He/ She should have passed his/ her qualifying exam from Delhi School/College and must have SC/ST/OBC certificate issued by the Competent Authority of Govt. of NCT of Delhi only.
- (c) **Reservation in OBC Category is not applicable for Master's Level and Postgraduate Diploma programmes.** The Reservation for OBC category is applicable only in University School of Studies and Govt. Colleges (affiliated to GGSIPU) only. The reservation for OBC Category is only for candidates who are from Delhi Region. Certificate issued by Govt. of India or any state government will not be accepted under any circumstances.
- (d) For claiming reservation against OBC category in Delhi Region, candidate has to upload valid OBC category certificate issued by a Competent Authority of Delhi in accordance with the list of OBC category as per Govt. of NCT of Delhi. A certificate issued by a Competent Authority of Delhi to an individual on the basis of Caste Certificate of his/her parents from another state will not be accepted for claiming a seat under OBC category.
- (e) And if, OBC certificate is issued prior to 31.03.2023 then it is mandatory for candidates to upload OBC Non Creamy Layer certificate which should be issued after 31st March, 2023 along with their OBC certificate.
- (f) The Reservation for EWS category is applicable only in University School of Studies and Govt. affiliated Colleges only. This will be implemented in accordance with the Govt. of India and Govt. of NCT of Delhi orders as applicable. **EWS Certificate should be issued after 31st March, 2023 stating valid for year 2023-24.**
- (g) For claiming reservation on a seat reserved for **DEFENCE** Category, the candidate have to upload the duly filled and signed **Appendix 1** of Admission Brochure 2023-24 issued by the competent authority as mentioned in Admission Brochure 2023-24 along with supporting documents.
- (h) **Reserved Category Candidates who fail either to upload documents as per notified schedule or whose documents are not in order will forfeit his/her right for the reserved category claimed and will automatically be converted to General Category as per University rules.**
- (i) The reservation certificate should be issued from the respective state under the "Region" in which the reservation is claimed.
 - ⇒ Candidate should be an Indian/ Overseas Indian / Nepal citizen. Non-Resident Indians and Foreign Nationals are not eligible.
 - ⇒ The candidate should be medically fit to pursue the allocated course on medical examination.
 - ⇒ The candidate should have attained the age of 17 years on or before 31st December of the year of his/her admission to the first year of the Course.
 - ⇒ No provisional admission will be done for any result awaited or Compartment / Supplementary cases.
 - ⇒ The admission to the **ACMS i.e. Army College of Medical Sciences**, is for the children of eligible serving Army personnel, Ex Army personnel and war widows/widows of the Army. There is no seat reserved in Defence Category for non-army ward/widows seats in Army College of Medical Sciences (ACMS). Hence, the para 5 of clause 7.1.4 of Chapter 7 of Admission Brochure 2023-24 stands invalid.

II) GENERAL INSTRUCTIONS:

- (a) The candidates must read the conditions of eligibility as given in the Admission Brochure carefully and must satisfy themselves regarding their eligibility for admission in various programmes before registering online for admission and submitting the fees.
- (b) It is the sole responsibility of the candidate to ensure that they fulfil the minimum eligibility criteria in the programmes they seek admission; the correctness of the details filled with respect to region; category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or untrue, the admission to the programme shall be cancelled and the fees will be forfeited.
- (c) In order to avoid last minute rush, the candidates are advised to apply early enough. The University will not be responsible for network problems or any other problem of such nature for submission of online application during the last minute.
- (d) Candidates claiming seat in Delhi region must have passed the qualifying examination from any school/college located in Delhi only (IN CASE OF MBBS – i.e. 11TH AND 12TH BOTH SHOULD BE FROM DELHI). Allotment of seats in wrong region on account of incorrect filling of form will lead to cancellation of the allotment at any later stage and candidate will automatically lose the right to the seat in his bonafied region if not available at the time of cancellation of seat.
- (e) Any other terms and conditions as defined by the Statutory body/Competent Authority, shall be applicable for counselling process/admission to MBBS programme for academic session 2023-24. In the event of any provision mentioned in the Admission Brochure being found to be at variance with any binding regulation/directions of any statutory body, then the higher norms will prevail.

III) REGISTRATION: ENROLLMENT FOR CENTRALIZED ONLINE COUNSELLING PROCESS:

For Enrolment, the candidate has to enter his/her details on the admission website <https://ipu.admissions.nic.in>. In this stage, all the NEET UG 2023 qualified candidates, as per eligibility criteria, are required to register online from any place convenient to them. The candidate can register only once.

- i. **Candidate Registration:** The candidate is required to enter Name, Father's Name, Mother's Name, DOB, Gender etc. choose a password for subsequent logins. After successful registration, an application number will be generated by the system and provided to the candidate. Candidate will login by using system generated application number and password to complete the remaining activities.
- ii. **Sign-in:** Candidate will use the Application Number/ Application Sequence No. and chosen password during registration for subsequent logins. After successful login, candidate will be redirected to the home page to perform the remaining activities like Application form submission, upload images and documents, registration fee payment and choice filling etc.
- iii. **Multistep Application Form Submission:** After submission of registration form, candidate will login to complete the remaining activities. To complete the registration process, candidate will provide personal detail, contact detail, Qualification and Competitive Exam detail etc.
- iv. **Uploading of Documents:** Candidate need to upload the scanned images of mandatory documents as per the predefined size and format.

- v. **Registration Fee Payment:** Applicant will pay the registration fee online using EPG Services after uploading of documents. The payment gateway services have the various options like credit card, debit card, net banking etc to pay the registration fee.
- vi. **Email and Mobile Number Verification (Optional):** A separate link/button will be available in candidate's home page for verification of his/her email address and mobile no.. Candidate can verify his/her email address by sending the OTP.
- vii. It is in the interest of the candidate to remember the password and keep it confidential, to avoid misuse by others for which University will not be responsible.
- viii. **Change password:** The candidates can also change the password if required using the change Password menu.
- ix. Candidates are advised to check all the filled in details before taking the print out.
- x. All candidates must take two print outs of the Registration Form.

IV) SUBMISSION OF COUNSELLING PARTICIPATION FEE:

- (a) Both the Application Fee of Rs. 1500/- (in respect of newly registered candidates) and Counselling Participation Fee Rs.1000/- plus charges (to be deposited by all candidates) as applicable, are non-refundable. The taxes and charges applicable has to be paid by the candidates and is non-refundable.
- (b) For depositing the Counselling Participation Fee, the candidate has to visit the GGSIP University admission website <https://ipu.admissions.nic.in>.
- (c) After registration as mentioned above, the candidate will get an option of payment through: (i) Net Banking / Credit Card/ Debit Card.
- (d) Candidates are advised in their own interest to complete the process of fee submission online much before the closing date and not to wait till the last minute to avoid transaction failure or any other technical fault due to congestion on web server on account of heavy load on internet / website.
- (e) If the fee is paid through credit / debit card and status is not 'OK' it means the transaction got cancelled and the amount will be refunded to concerned credit / debit card. Such candidates should immediately pay the fee once again.
- (f) Submission of registration fees is just a part of the counselling process, just payment of this fees does not entitle the candidate to admission.

V) RESULT / ALLOCATION OF SEATS IN EVERY ROUND:

After the choice filling period is over, all the choices/preferences filled by the candidate will be considered for online allotment of seat as per merit and respective category and region.

- 1. All such candidates, as listed below, will not be considered for allotment of seat:
 - i. Candidates who have not paid the counselling participation fee,
 - ii. Paid the counselling participation fee but not registered or vice versa,
 - iii. Paid the counselling participation fee and registered but not filled choices/preferences.
 - iv. Candidates who were allotted a seat in any round but did not pay the part academic fees of 60000/- shall not be considered in subsequent round of counselling. Also, the candidates who were allotted seat in /riybd 01 Counselling conducted by the University, paid the Part Academic Fee of Rs. 60,000/-, however, opted for withdrawal, did not report to the allotted college and/or reported to the allotted college/institute and subsequently withdrawn his/her admission are not eligible to participate in Round 02 counselling.
 - v. Any other condition as defined by the communication of the University.
- 2. Results can be checked by the candidate through his/her account login given during the registration process.
- 3. Candidate can print Provisional Allotment Letter, if the seat is allotted to him/her.
- 4. The option of printing the Provisional Allotment Letter will be available only for the respective round; within the specified period and the record will not be available in the subsequent round of online counselling.

5. After the allotment of seat, the candidates will have to pay the part Academic Fee of Rs 60,000/- to confirm the allotment and participation in the subsequent round of counselling, failing which, the candidate will lose any claim to the allotted seat and the candidate will not be considered further for any subsequent round of online counselling, even if he wishes to.
6. Candidate can pay the admission fee against the provisionally allotted seat through Online option which are same as in case of the Counselling Participation Fee.
Through Net Banking/Credit Card/Debit Card.
7. Candidate can print
 - i. Provisional Allotment Letter
 - ii. Proof of payment of Part Academic Fee Payment receipt of Rs.60,000/ will be available in candidates profile-
It will be available only for the respective round within the specified period.
8. **Candidates will be allotted seat on the basis of Choices filled and availability of seat at his/her rank in preferred choices. It is to inform that the seat allotted through Online Counselling on the basis of Choices/Preferences filled by candidate will be binding and there will be no claim of the candidate on the previous allotted choice if new choice has been allotted to him/her.**

VI) FREEZE / FLOAT OF ALLOTTED SEAT AFTER EVERY ROUND OF COUNSELLING:

1. After every round of Counselling, if the candidate is satisfied with the seat allotted to him and does not want to participate in subsequent rounds of counselling for upgradation, he/she can freeze his/her allotted seat by clicking the freeze option available in his/her account in the counselling website within the specified time period.
2. If the candidate wants to upgrade his/ her choice by participating in next round of counseling as per his/ her filled choices should choose option Float.
3. Those candidates who opts "FLOAT" option will be able to participate in next round of counselling and his/ her allotted seat will get retained if the candidate is not able to get higher choice.

VII) WITHDRAWAL AND FEE REFUND AFTER ONLINE ROUNDS OF COUNSELLING:

1. After depositing of Academic Fees, if a candidate wants to withdraw the admission against the allotted seat, he/she can apply for withdrawal by clicking on the withdrawal option available in his/her account in the admission website within the specified time period, following the online withdrawal procedure.
2. All candidates who have withdrawn, freezed their seat, not paid the Part Academic Fee of Rs. 60,000/- and who do not fulfill the eligibility criteria, will not be participating in the subsequent round of online counselling and the vacancies with respect to such candidates will be considered for allotment of seat in subsequent Rounds.

VIII) REPORTING/JOINING OF CANDIDATES TO THE ALLOTTED INSTITUTE/COLLEGE:

- i) After declaration of result of Round 02 of Online Counselling conducted by the University, the candidates allotted seat, have to report to their respective allocated medical colleges/institutions for verification of documents and payment of balance Part Academic Fee as per the Offer letter of result of Round 02 of Online Counselling.
- ii) After allotment of seat in the Round 02 of Counselling, the candidate, if he/she has made the payment of Part Academic Fee of Rs. 60,000/-, can generate Provisional Admission Slip.
- iii) Proof of payment of Part Academic Fee receipt of Rs. 60,000/- is available in the candidate's profile.




