For admission to M.Sc. (Medicinal Chemistry and Drug Design) (MCDD) (CET Code 405) and M.Sc. (Bioinformatics) (CET Code 411) programme through CUET qualified candidates, an offline counseling would be conducted in the Centre of Excellence in Pharmaceutical Sciences on 23.09.2024 at 10:00 a.m.

The candidates are requested to carry the filled CUET form along with their score/merit card in the CUET examination. The admission is based on merit on the basis of CUET Rank.

#### **Mode of Payment:**

- 2. The student may also deposit the fee through UPI/Online at the time of admission.

# Documents required for Verification and Allotment of Seats (along with a set of photocopies):

- a. Eight passport sized photograph
- b. CUET Rank Card/Merit Order of CUET 2024 (copy)
- c. CUET 2024 Admit Card (in original)
- d. Filled admission verification form as per Appendix 6 of Part-F of Admission Brochure 2024-25.
- e. Proof of date of birth (Secondary School 10<sup>th</sup> Mark sheet and Certificate) and 12<sup>th</sup> Mark sheet and Certificate (original and photocopy)
- f. Mark sheets / Certificates of qualifying examination:
  - The candidate will be required to bring the original certificate / mark sheets of all the year wise or semester wise in original along with photocopy of certificates / mark sheets of qualifying examination.
- g. For Distance / Open Learning Cases:
  - In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his/her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.

# h. Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2024-25 (As per Appendix 5).

i. Result Awaited:

Candidates seeking admission as result awaited candidate must have to submit Appendix 4 of Part-F of Admission Brochure 2024-25.

- j. Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted Officer in original, not more than 06 (six) months old.
- k. Application regarding age relaxation with necessary approval shall be submit prior two days before the commencement of Offline Counseling (if necessary).
- It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counseling/allotment of seats, candidate should ensure that he/she fulfills all eligibility conditions as laid down in the respective Admission Brochure for the session 2024-25. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.
