CAPITATION FEE FOR MANAGEMENT QUOTA ADMISSIONS 2023-2024****BEWARE OF TOUTS PROMISING ADMISSIONS IN GGSIP UNIVERSITY**

1. In continuation to University's Notification No. 101/2023 dated 27.07.2023 read with University's Notification No. 24/2023 dated 24.06.2023; regarding Demand of Capitation Fee in the Name of Management Quota and not to fall prey to misleading and unscrupulous advertisement by Affiliated Colleges of GGSIP University.
2. It has been directed by the Admission Regulatory Committee constituted vide Notification dated 13<sup>th</sup> April, 2023 of Department of Higher Education, Govt. of NCT of Delhi to issue Notice instructing colleges and parents not to indulge in capitation fee for management quota admissions 2023-2024.
3. In this context, all the affiliated institutions are hereby directed to maintain transparency in admission in Management Quota seats, in case a particular affiliated college has demanded capitation fee from the parents of the candidates promising admission in Management Quota, the University reserves the right to process for deaffiliating such colleges in accordance with the laid down rules/procedure against the affiliated colleges seeking capitation fee as the same is in direct violation to the provisions of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee Regulation of Admission Fixation of Non-Exploitative Fee and Other Measures to Ensures Equity and Excellence) Act, 2007.
4. Candidates and their parents are also advised not to fall prey to such illegitimate demands by any person, agencies or any representative claiming to be individual of any affiliated college.
5. The candidate shall be responsible himself for resorting to illegal tactics for seeking admission by paying any capitation fee.
6. The parents/candidates are advised not to fall prey to such messages being sent by agents/touts who have fraudulently got access to the telephone numbers/emails of the candidates.


**COMPLAINTS REGARDING DEMAND OF CAPITATION**

The University reserves the right to process for deaffiliating such colleges in accordance with the laid down rules/ procedure against the affiliated colleges seeking capitation fee as the same is in direct violation to the provisions of The Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee Regulation of Admission Fixation of Non-Exploitative Fee and other Measures to Ensures Equity and Excellence) Act, 2007.

Candidates and their parents are also advised not to fall prey to such illegitimate demands by any person, agencies or any representative claiming to be individual of any affiliated College.


The candidate shall be responsible himself for resorting to illegal tactics for seeking admission by paying any capitation fee.


**ADVICE TO CANDIDATES NOT TO FALL PREY TO MISLEADING AND UNSCRUPULOUS ADVERTISEMENT BY FEW AFFILIATED INSTITUTES**

It has been learnt that few self financing affiliated institutes are issuing advertisement in gross violation to the provisions of the Delhi Professional Colleges or Institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 8 of 2007) by asking prospective candidates to visit their institute for direct admission. It has also been learnt that few affiliated institutes in violation to provisions of law are luring prospective candidates of GGSIP University for granting them direct admissions in other Universities in NCR by promising to allow sitting in the premises of institute affiliated to GGSIP University.

This action of affiliated institutes is gross violation of the terms of affiliation and also violation of provisions of the Delhi Professional Colleges or Institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 8 of 2007) which only stipulates that the admissions in GGSIP University will be through centralised online counselling and only 10% seats in management seats in the self financing institutions can be filled up by the management of the affiliated institutes through prescribed notified procedure.

The University is in receipt of the complaints and necessary action as per law shall be initiated for issue of mischievous, unscrupulous advertisement against the law for misguiding the prospective candidates.

The candidates are advised to ignore such unlawful advertisement and telephonic calls from either the affiliated institutes or any agency as these advertisements are misleading, deceptive and unlawful. The prospective candidates are advised only to read the instructions issued by the University which are uploaded on the University website. The University shall not be responsible if the candidate falls prey for such advertisements and the University shall not regularise any such fraudulent admissions taken by the candidate on the basis of illegal, unlawful advertisements issued by any of the institute affiliated to GGSIP University. The Directors/Chairman of the affiliated colleges shall also ensure that no such advertisements promising direct admissions are issued.

## **Beware of Touts Promising Admissions in GGSIPU**

The Admissions in GGSIP University and all affiliated Colleges in all the programmes are through Centralized Counselling process which is purely on the basis of merit of the Candidates in the CET examinations conducted by the University or merit in the entrance examination conducted by National Testing Agency.

The Admissions in GGSIP University and all affiliated Colleges are through a complete transparent merit based process through a Centralized Counselling held online or for few programmes in offline mode

The University has received complaints from some candidates and their parents that some agents / touts claiming to be representatives of the Affiliated Colleges / Institutes of the University are promising these candidates to get admitted in different programmes in University Affiliated Colleges / Institutes and thereafter asking these candidates to transfer money through different App or demanding money in Cash. These agents / touts are also sending messages / emails / whatsapp message to the Candidates promising Direct Admission in the Affiliated Colleges / Institutes. These touts / agents have fraudulently obtained access to the personal mobile numbers / emails of these Candidates. The University is contemplating to file FIR against these persons for having obtained the personal details of the Candidates through illegal means with the intention to cheat / fraud.

The parents / candidates are advised not to fall prey to such messages being sent by agents / touts who have fraudulently got access to the telephone numbers / emails of the Candidates.

Please note information regarding Centralized Counselling is provided by the University on the GGSIP University website. Candidates are advised only to follow the instructions as given in the Admissions Notices uploaded at GGSIP University official website, i.e. [www.ipu.ac.in](http://www.ipu.ac.in) and Online Counselling website <https://ipu.admissions.nic.in>

The candidates or the parents are requested to kindly inform the PRO / Chief Vigilance Officer, GGSIP University in case they are approached by any touts or agents claiming to be representative of the University or of any Affiliated Colleges / Institutes, promising to get the Candidates admitted in the University Affiliated Colleges

The PRO of the University has been directed to lodge FIR against all such persons who are indulging fraudulent act of misrepresenting themselves as University Affiliated Colleges / Institutes representatives and misguiding the Candidates for direct admission in the Affiliated Colleges / Institutes
