### TERMS AND CONDITIONS FOR SALE OF SCRAP ON " AS-IS-WHERE-IS" BASIS

 The Registrar, GGS Indraprastha University reserves the right to accept or reject any tenders without assigning any reason thereof.

- The sale will be on "AS-IS-WHERE-IS" basis. Interested parties may inspect the scrap material during office hours after obtaining permission from In-charge / Section Officer Central Stores and after endorsing proof of identity at University entry gate.
- 3. The duly competed tender in sealed envelope as per attached Bid-Tender-Form along with EMD Demand Draft for the amount as shown against each lot in favor of "Registrar, GGSIPU" should be deposited in the office of the In-charge, University Central Store on any working day during working hours from 21/11/2024 to 28/11/2024 and receipt duly signed be obtained from SO, UCS Branch
- 4. The successful bidder shall have to pay the total amount of bid within two days failing which the EMD deposit will be forfeited, and the next successful bidder will be given the opportunity.
- 5. The successful bidder after making full payment will be required to remove the scrap material form the University premises within three working days or as per directions of UCS Branch
  - The EMD amount will be adjusted towards the payment of scrap material of the successful bidder.
  - In Case the successful bidder fails to remove the scrap material as per directions or within the specified period the University will charge Rs.1500/- per day for unauthorized stay in the University campus and the University will not be responsible for any damage.
  - 8. Tenders shall be submitted in UCS Branch in the presence of authorized staff only. Bids without EMD Demand Draft for any lot will not be accepted / considered.
  - All the bidders are required to submit attested photocopy of their ID / Aadhaar Card / Government issued identity proof, along with EMD Demand Draft. The eWaste Scrap bidders shall submit proof of their registration as per Government regulations.
  - 10. The rate has to be quoted above Reserve Price as shown against each lot. The GST will be paid as per Govt. stipulated rates as applicable for each lot. The EMD of Unsuccessful bidders will be returned by next one working day. However, the EMD of successful bidders will be adjusted towards the quoted amount.
  - 11. The tenders will be opened on 28.11.2024 at 03:00 PM by the authorized staff in the presence of bidders or their authorized representatives who wish to be present on the occasion after having endorsed their particulars at the University entry gate.
  - 12. The bidders should ensure that there is no cutting/ overwriting in the quoted rates.
  - 13. The price quotation should be in numerical terms as well as in words. The cost of transportation and loading of the material shall be borne by the final bidder.
  - 14. In case of any dispute arising between the bidders and University, the decision of the Competent Authority of the University shall be final and binding on the bidders.
  - 15. In case of tie for any lot the decision of the University shall be final and binding. In case of tie, on the spot bidding of atleast +5% or more may be allowed for every next three bids only between the bidders. In case tie still persists then Committee may adopt otherb means of lottery or frash bidding for affected lots only. All legal disputes shall be subject to jurisdiction of Delhi Courts.
