3. CET Rank Card/ Merit Order and CET Admit Card 2024.
4. NLT Score/ Rank Card and NLT Admit Card 2024.
5. Proof of date of birth (Secondary School Mark- sheet & Certificate) (Original and Photocopy).
6. Mark- sheets/ Certificates of qualifying examination.
7. The candidate will be required to bring the Original certificates/ Mark- sheets of all the year wise or semesters wise in original along with photocopy of certificates/ marks- sheets of qualifying examination. (self attested photocopy)
8. For Distance/ Open Learning Cases: In case of students who have passed the qualifying examination through distance/ open education system of any recognized University/Board/ Institution, the necessary documentary evidence related to location of his/ her study centre i.e study centre proof, certificate from the University imparting open/ distance education certifying the location of the study centre to be submitted.
9. Medical Certificate in original.
10. Online Registration form 2024.
11. Copy of online Reserved Categories verification slip.



12. Reserved Category Certificate:

All reservation category candidates who are seeking admission in reserved category in SC/ST/DEF/PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. The defence category candidates, in addition to all the documents shall also bring appendix 1 duly completed as detailed above para.

13. Conduct and Character certificate in original from head of the institution from where the qualifying examination has been passed or from Gazetted officer in original not more than 6 months old.
