All the GATE qualified candidates who have registered in GGSIP University for Academic Session 2023-24 and all the qualified candidates, whose names appeared in the merit list, drawn on the basis CET 2023, for M.Tech. (Biotechnology), CET Code-148 shall report in person for Spot Counselling for 'Verification of Documents' and 'Allotment of Seats', at the venue of Counselling; on the date and time mentioned below.

# 3. <u>Eligibility Criteria for Programme M.Tech (Biotechnology), CET Code-148</u>

Minimum 60% or equivalent in the qualifying examinations as under:

- a) B.E./B.Tech. in Biotechnology / Chemical Engineering / Biochemical Engineering / Food Technology) or equivalent/ or B. Pharma/MBBS.
- b) M.Sc. (Biotechnology/ Biochemistry/ microbiology/ Bioscience/ Genetics/ Life Science) or equivalent

### 4. <u>Documents Required for Verification and Allotment of Seats:</u>

- a) Bank Draft(s) of Rs. 1,33,000/- (Including Rs. 1,000/- Counselling Processing Fee (one time non-refundable) in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his/her name, date of admission, phone, address, mobile no., name of the programme, CET Rank and CET Roll Number on the back of the Bank Draft(s). Please refer to the Chapter 14: 'Fee Structure', Part-E, Admission Brochure 2023-24.
- b) Four passport sized photographs (same as that in admit card)
- c) Qualified and Valid GATE Score Card (Original), if applicable.
- d) Experience Certificate (original), if applicable.
- e) CET-2023 Admit Card in Original and CET 2023 Result
- f) Copy of Admission verification form (Copy of Admission verification form as per Appendix 6 in Part F of Admission Brochure 2023-24.)
- g) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- h) Mark-sheets / Certificates of qualifying examination:

The candidate will be required to bring the Original certificates / Marksheets of all the year wise or semester wise in original along with photocopy of Certificates / Mark-sheets of qualifying examination.

i) Physical Fitness Certificate:

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2023-24 (As per Appendix 5).

i) Reserved Category Certificate:

All reservation category candidates who are seeking admission in reserved category in UR&EWS/ SC / ST / DEF / PWD must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category. The Defence Category candidates, in addition, shall also bring Appendix 1 duly completed. The Appendices are available in Part F of Admission Brochure 2023-24.

k) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.

- Application regarding age or any other relaxation with necessary approval (if necessary).
- m) The candidate claiming reservation against UR&EWS category must produce certificate issued by the Competent Authority at the time of verification of documents and allotment of seat.
- 5. <u>Seat Matrix</u>: To be displayed at the time of counselling.

6. Spot counselling fee

A counselling fee of Rs. 1000/- shall have to be paid by all eligible candidates to participate in the open house counselling.

**Note:** The candidate who has withdrawn after 1<sup>st</sup> or 2<sup>nd</sup> round of counselling will be allowed to take admission during spot counselling.

## 7. Withdrawal of Admission

All the requests for withdrawal of admission, shall mandatorily be submitted in the prescribed format available in Part F, Admission Brochure 2023-24, (Appendix-11). The same shall be submitted in the Admissions Branch, Administrative Block, Guru Gobind Singh Indraprastha University, Sector 16C, Dwarka, New Delhi - 110078. The last date for withdrawal of admission is 13<sup>th</sup> September, 2023.
