1. For seeking admission in remaining/left over vacant seats of **ONE YEAR POST GRADUATE DIPLOMA IN CYBER SECURITY, CYBER DISASTER AND BLOCKCHAIN TECHNOLOGY**, (1 year- 3 Trimester) the eligibility criteria as approved, is reproduced as follows:-

Eligibility Criteria: The applicant should possess any of the following degree with at least 60% marks or equivalent CGPA for seeking admission to PG Diploma Programme. In case the candidate possess multiple qualifying degrees, the higher percentage out of the qualifying degrees, for which the data is filled in the application form would be considered. The applicants with the following degree are eligible:

- a. B.Tech/M.Tech(In any discipline)
- b. MCA
- c. M.Sc(Maths/Physics/IT/Informatics/CSE/ECE)
- d. BCA
- e. B.Sc(Maths/Physics/IT/CSE/ECE)

2. The Candidate claiming the reservation under EWS/SC/ST/OBC/Physically Handicapped/Defence Category must produce certificate issued by the competent authority at the time of verification of document and allotment of seat as per Admission Brochure.

3. Document(s) required at the time of Counselling /Admission : Original(Returnable) and One set of self-attested xerox copies).

The reservation certificate should be issued from the respective state/region in which the reservation is claimed e.g. in case any candidate claims for the seat reserved for DSC category then he has to bring SC certificate issued by Govt. of NCT of Delhi and also passed his/her qualifying exam from Delhi.

Note:-

(a) The Original Certificates (except the medical certificate & Character certificate) will be returned to the candidates after verification.

(b) In case if any of the above document(s) is/are in any language other than Hindi/English, then authentic translation in English/Hindi shall have to be produced duly verified by the issuing institution/gazetted officer (original and photocopy) by the candidate at the time of Counselling/Admission. Failure on the part of candidate to produce the requisite authentic translation may result in refusal of admission by the Admission Officer, for which only the candidate will be responsible.

(c) In case the Degree/certificate has been obtained from some University of any other country then an equivalence certificate must be obtained from Association of Indian universities prior to attending the counselling.


(d) The required certificate(s) for reserved categories/classes will be essential at the time of the counselling/admission and no provisional admission shall be admissible for want of caste/category certificate from the local competent authority. Further, the caste/ category certificate should invariably be in the name of candidate himself/herself and not in favour of respective parents/ guardians.

(e) In case of married woman applying under reserved category, she has to produce the caste certificate in the name of herself. Certificate in the name of husband/mother/father is not acceptable.

(f) The candidates who have passed the qualifying examination through Distance/Open Education system of any recognized University/Board and fails to provide the proof of his/her study center being located in Delhi shall not be considered for Delhi region Seats, and shall be considered for admission in the Outside Delhi Region. The proof of Study Center has to be from the Graduating university certifying that study center is their approved Study Center.


