IMPORTANT NOTE FOR CANDIDATES WHO DID NOT DEPOSIT RS.1500/- AS APPLICATION FEE.

The University also displayed a list titled "List of candidates registered but not paid the Application Fee of Rs. 1500/- on the GGSIP University portal for Admission in the programme B.Arch, (Code 100) for the Academic Session 2024-25". Such candidates if interested in participating in the counseling shall be required to visit the University on the above dates alongwith the required documents and a Demand Draft of Rs.1500/- in favour of "Registrar, GGSIP University", payable at Delhi, for getting registered & Verification of Documents.

NOTE: Any candidate who has does not attend the counseling for verification within the allotted slot, on his/her Sl. No., shall be entitled to attend the counseling for verification in the subsequent slot/day within the notified period as above.

Important:

- 1. It is mandatory for all registered candidates in programme B.Arch. (CET 100) to report for Verification of Documents.
- 2. The final merit list will be prepared after verification of documents of all the reported candidates.
- 3. Authorized representative (with the permission of the Director Incharge (Academic), Guru Gobind Singh Indraprastha University) may appear for verification of documents.
- 4. In case, a candidate/representative does not appear for document verification, the candidature of such candidates would be forfeited and the candidates shall not be considered for admission and will loose their claim to participate in the counseling for admission.
- 5. Candidates are requested to adhere to the displayed schedule for reporting.
- 6. Candidates must fulfill the eligibility conditions as laid down in the Admission Brochure 2024-25.

Eligibility Criteria:-

- 7. 1. Admissions will be made on the basis of NATA Score and the percentage of Aggregate marks, i.e., (percentage will be calculated considering subjects including Physics, Chemistry, Mathematics and English among all paper offered to the student) obtained in the qualifying examination, i.e. senior secondary level or equivalent. No candidate shall be admitted unless she/he has passed 10+2 scheme of examination with at least 50% aggregate marks in Physics, Chemistry and Mathematics and also at least 50% marks in aggregate or passed 10+3 diploma examination with mathematics as compulsory subject with at least 50% marks in aggregate.
 - 2. No candidate shall be admitted to architecture course unless she an examination at the end of the 10+2 scheme of examination with Physics, Chemistry & Mathematics subjects of passed 10+3 Diploma Examination with Mathematics as compulsory subject.
 - 3. Merit list shall be prepared based on:
 - a. Architectural Aptitude (NATA score): 50%
 - b. Qualifying Examination (i.e., 10+2 OR 10+3 years diploma recognized by the Central / State Governments): 50%.

No Result Awaited candidates will be included in the merit.

- 8. The Tentative Merit List of reported candidates will be displayed on 08/07/2024.
- 9. Representation (if any) from applicants in respect of Tentative Merit List will be invited from 09.07.2024 (UPTO 4:00 P.M).
- 10. The Final Merit List of candidates (whose documents has verified) will be displayed on 10/07/2024.

11. Documents required for verification at the time of reporting:

Candidates need to bring the required documents both in photocopy and originals. The photocopies will be retained by the University and the originals will be returned to the candidates after verification.

- a. Copy of GGSIPU Online Registration Form
- b. Class X certificate for verification of DOB. (Photocopy and Original)
- c. NATA Score Card. (Photocopy and Original)
- d. Certificate of Qualifying Examination (i.e. 10+2 OR 10+3 years diploma recognized by the Central / State Governments OR International Baccalaureate Diplomas). (Photocopy and Original)
- e. Reserved Category Certificate: All reservation category candidates who are seeking admission in reserved category in SC/ST/OBC/DEF/PWD/JKM must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category as per the reservation policy and information published in the Admission Brochure 2024-25. The Defence Category candidates in addition, shall also bring Appendix (1) duly completed. The Appendices are available in Part F of Admission Brochure 2024-25. (Photocopy and Original)
