NOTICE INVITING EXPRESSION OF INTEREST (EOI)

Guru Gobind Singh Indraprastha University is established by Government of NCT of Delhi under the provisions of Guru Gobind Singh Indraprastha University Act, 1998. This is an affiliating and teaching University that aims to facilitate and promote studies, research and extension work in emerging areas of higher education with focus on professional education in the disciplines of engineering, technology, architecture, management, law, medicine, pharmacy, physiotherapy, nursing education, journalism and mass communication, etc.

Guru Gobind Singh Indraprastha University is organizing its **25th Annual Cultural Festival 'Anugonj 2026'** from **04th to 6th February, 2026** in its campus at Sector-16C, Dwarka, New Delhi. Anugonj which is one of the largest festivals of Delhi. This is an event that attracts over 90,000 plus students as participants and visitors from more than 120 affiliated colleges of the GGSIP University.

The three-days Annual Cultural Festival 'Anugonj-2026' will also have star attraction from renowned Bollywood Singer/Rock Band etc. During the last five years, stars like Armaan Malik, Salim Sulaiman, Sukhvinder, KK, Kailash Kher, Benny Dayal, Jubin Nautiyal, Sugandha Sharma etc. performed in Anugonj Fests.
