Office Memorandum

Subject: Amendment to Guidelines of Prime Minister's Internship Scheme- Pilot Project.

Reference is invited to O.M. No. CSR-13/35/2024 dated 3rd October 2024 which lays down the aidelines of the PM Internship Scheme - Pilot Project ("Guidelines"). In this regard, it is stated that the following amendments to the aforesaid O.M. are made with immediate effect:

- i. Para 5.5.3 of the Guidelines, is substituted with the following:
 - "5.5.3 Registration/Application Process for the candidates: Eligible candidates would have to register themselves on the Portal. Based on the information provided by the candidates, a resume will be generated by the Portal. A browsing facility will be made available to candidates for preferred sectors, functional roles, locations, and other criteria. Candidates may then apply for up to three (3) internship opportunities based on their preferences, including location (state, district), sector, functional role, and qualifications."
- 2. Annexure I of the Guidelines of the PM Internship Scheme-Pilot Project lays down the Implementation Mechanism for the PM Internship Scheme. The following amendments are made to tl Annexure I of the Guidelines:
 - i. Para 2.4 of Implementation Mechanism is substituted with the following:
 - "2.4 Candidate Application: After the Aadhaar authentication by the candidates, a browsing facility will be made available to candidates for browsing through internship opportunities, based on their preferred sectors, functional roles, locations, and other criteria. Candidates may then apply for up to three (3) internship opportunities based on their preferences, including location (state, district), sector, functional role, and qualifications."
 - ii. Para 4.2 of the Implementation Mechanism is substituted with the following:

 "In case of a medical emergency, the demise of a family member, or such extenuating and emergency circumstances, a sabbatical of up to two months may be granted to the

intern, in accordance with company policies and/ or any directives issued by the Ministry from time to time. No financial assistance shall be provided during the sabbatical period; however, the intern shall be permitted to rejoin and complete the remaining duration of the overall 12-month internship period, excluding the sabbatical period. For instance, if a candidate takes a one-month sabbatical, his/her internship will extend up to 13 months from the internship start date."

3. Selection criteria for under-represented companies

The Guidelines of the PM Internship Scheme Pilot Project states that the top 500 companies have been identified by the Ministry on the basis of their average CSR expenditure of the last three years. Apart from these, any other company/ bank/ financial institution desirous of participating in the Scheme, may do so with the approval of the Ministry of Corporate Affairs (MCA), which would take a view keeping in view under represented sectors and areas in the above mentioned 500 companies.

In view of the above, it is hereby stated that the Ministry of Corporate Affairs will consider the following criteria, to permit the companies to participate in the Scheme:

a. Financial Criteria

- Turnover: The company must have an annual turnover of more than ₹1,000 crore, during the immediately preceding financial year; or
- Net Worth: The company must have a net worth of more than ₹500 crore, during the immediately preceding financial year.

b. Internship Capacity

- Pilot Phase: The Company must commit to take at least 300 interns during the pilot phase.
- 4. This issues with the approval of Competent Authority.
