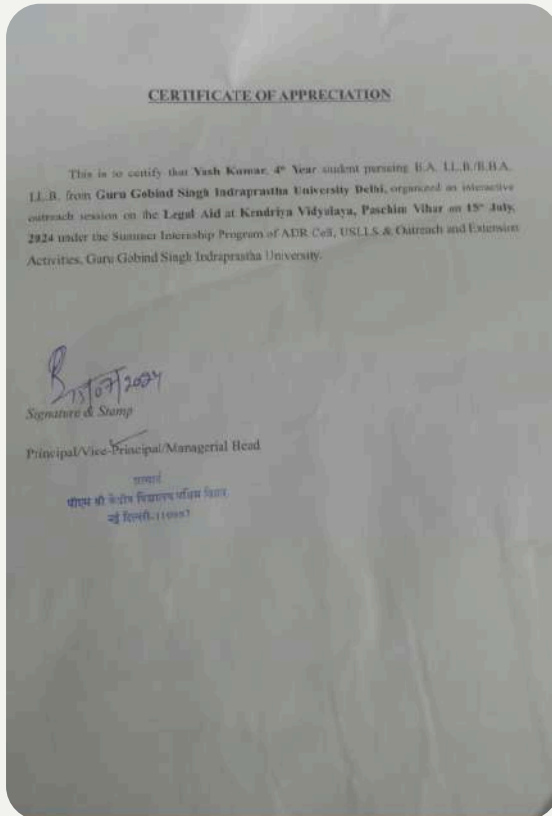
In collaboration with Naye Pankh NGO, focused on the theme of "Mahila Sashaktikaran" or women's empowerment. Held in a slum area of Kanpur, the session was led in person by Devanshi Bajpai, while the rest of the team—Ashtmi Verma, Shraddha Chatterjee, and Jiya—joined online via Google Meet. Initially, the turnout was low due to many residents being at work, but as the session progressed, over 50 households participated.

The session began with an explanation of women's constitutional rights, including legal protections against dowry, rape, and other gender-based crimes. The team also introduced alternative dispute resolution (ADR) as a mechanism for justice. The presentation used a prepared PDF to ensure clarity and accessibility.

Toward the end, government schemes supporting women were discussed in simple terms. The women responded with enthusiasm and gratitude, appreciating the relevance and practicality of the information shared. The program not only informed attendees but also gave the students hands-on experience with community outreach, aligning with the goal of legal empowerment at the grassroots level

Outreach Session on Constitutional Awareness and Free Legal Aid at Kendriya Vidyalaya, Paschim Vihar

15th July 2024

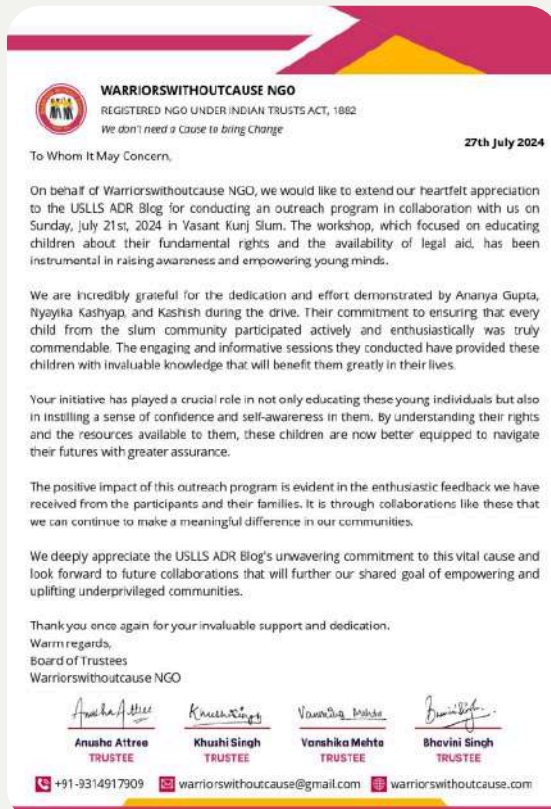


Conducted by: Yash Kumar, Mehal Maini, Adaa Sheikh, Anshika Agarwal. This outreach session focused on promoting constitutional awareness and the concept of free legal aid among school children. Held at Kendriya Vidyalaya, Paschim Vihar, the session began with a simplified introduction to the Indian Constitution. The facilitators emphasized the importance of understanding fundamental rights, such as equality, freedom, and education. Students responded with keen interest, asking thoughtful questions that led to deeper discussions.

The second half of the program introduced the concept of legal aid—an area unfamiliar to most students. By explaining how the government provides free legal services to those in need, the session helped dismantle the misconception that legal support is always expensive. To keep the session engaging, the team conducted a short interactive quiz which was well-received. Notably, several students expressed interest in legal careers by the end of the session.

The positive feedback from both students and teachers highlighted the session's effectiveness. The outreach achieved its goal of spreading legal awareness while empowering students with knowledge about their rights and available resources. The team recommended adding practical case studies and more interactive segments in future sessions to maintain engagement and build deeper legal literacy.

Outreach session on legal empowerment of Urban Poor Communities by Warriorswithoutcause NGO at Vasant Kunj, New Delhi 21st July 2024



This outreach, conducted in the slum areas of Vasant Kunj, New Delhi, in association with the NGO WarriorsWithoutCause, aimed at empowering urban poor communities through legal awareness. While individual student names aren't specified, the session was in line with the themes covered in other similar events: women's rights, child protection, digital safety, and government welfare schemes. The informal setting required a more conversational approach, allowing facilitators to engage with community members—particularly women and young girls—on issues like domestic violence, dowry, and workplace harassment.

The team likely used translated material and storytelling methods to explain legal provisions and available grievance redressal mechanisms. Emphasis would also have been placed on the use of Lok Adalats and legal aid clinics. Additionally, considering the growing penetration of mobile phones, there may have been a segment on online safety and awareness of cybercrimes. Participants were encouraged to ask questions and share their experiences, making the session highly interactive and empathetic.

This outreach successfully bridged the information gap in an underserved locality and encouraged residents to assert their rights, seek institutional help when needed, and share the knowledge with others in their community.

Outreach Session on Bullying in Saraswati Shiksha Sadan Inter College

22nd July 2024

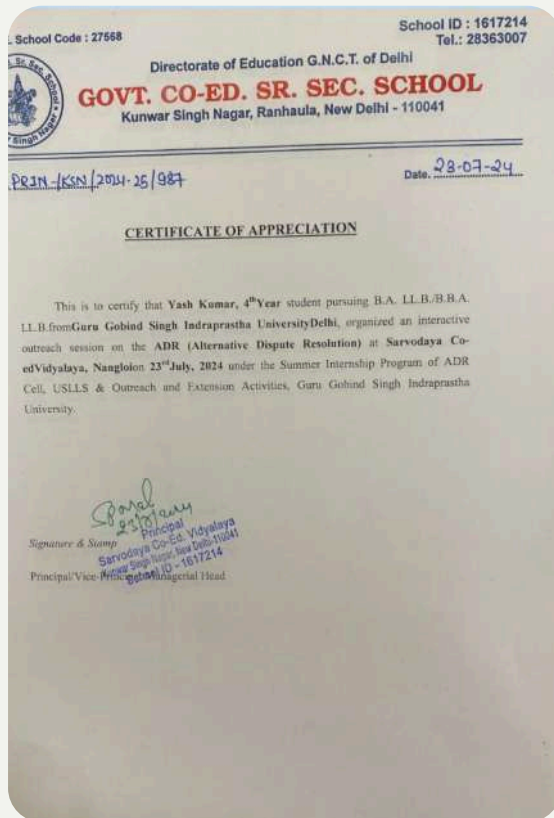
This outreach event tackled bullying in schools and proposed the use of Alternative Dispute Resolution (ADR) methods to address such issues. Conducted at Saraswati Shiksha Sadan Inter College, Devanshi Bajpai visited the school physically, while others participated online.

The team conducted a detailed survey among students and teachers to assess the frequency and impact of bullying and the limitations of existing punitive systems. Emphasizing a restorative approach, the team introduced ADR techniques such as mediation, conciliation, and restorative circles. These strategies, they explained, can help build a more inclusive and empathetic school environment by encouraging dialogue and mutual understanding.

The outreach underlined the importance of using such methods in tandem with traditional disciplinary mechanisms to better resolve conflicts and foster emotional well-being. It concluded with a powerful message on the necessity of addressing bullying through non-punitive, constructive channels. The session not only provided actionable insights to the students and staff but also highlighted how legal frameworks and dispute resolution methods can have a transformative role in education settings.

Outreach Session on ADR at Sarvodaya Co-ed Vidyalaya, Nangloi

23rd July 2024

The outreach program took place at Sarvodaya Co-ed Vidyalaya, Nangloi, with the aim of educating Class 12 students about Alternative Dispute Resolution (ADR). Many of the participants were unfamiliar with ADR concepts, making the session both timely and necessary. Facilitators explained ADR methods such as mediation, conciliation, arbitration, and Lok Adalats, emphasizing how these approaches offer quicker, cost-effective alternatives to traditional court proceedings.

The session also introduced the Arbitration and Conciliation Act, 1996, with a few students surprisingly already aware of its existence. This presented an opportunity to deepen their understanding of the act and its practical relevance. The discussion highlighted the role of Lok Adalats in easing the burden on courts while providing accessible justice to the public. Students were particularly interested in how ADR could be applied to real-life situations and asked many questions during the concluding Q&A session.

The team observed a high level of engagement, despite the novelty of the subject. This outreach effectively opened a new avenue of legal understanding for students who might not otherwise have encountered such concepts. It successfully combined theoretical explanations with real-world implications, making it one of the more conceptually enriching sessions.

Outreach Session on Safe Surfing: Protecting Yourself Online at Saraswati Shiksha Sadan

25th July 2024

This session was centered on "Safe Surfing: Protecting Yourself Online" and aimed at educating school students (especially classes 6–8) on cyber safety. With the growing use of social media among youth, They recognized the urgency of this issue.

Devanshi Bajpai visited the school in person, while the others participated via video call. The session covered critical topics such as cyber security, cyberbullying, online harassment, and responsible internet use. Students were taught how to protect their personal data, recognize scams, and respond to online threats. Laws like the IT Act and POCSO Act were briefly explained, along with helpline numbers and authorities to approach in case of cybercrime.

The team made the session interactive by allowing Q&A and providing educational handouts. The hybrid format facilitated dynamic engagement, and the information was well-received by students. The outreach succeeded in raising awareness about digital threats while empowering students to be vigilant and responsible digital citizens.

Legal Aid Drive at Slum Areas, Dwarka Sector 7, New Delhi

25th July, 2024



The outreach event was conducted in the slum areas of Dwarka Sector 7, New Delhi, aligning with the university's mission to empower underserved communities through education and legal literacy. While individual participants are not named, the format likely mirrored other slum-based outreach programs.

The session focused on educating women and children about their rights under the Constitution, gender-based laws, and the availability of free legal aid. Common topics included the Prevention of Domestic Violence Act, POCSO Act, and the importance of reporting crimes rather than tolerating injustice. Facilitators may have conducted informal group discussions to explain laws in relatable terms.

Emphasis was also likely placed on practical tools such as helpline numbers, government portals, and local NGOs that offer support. The session might have included roleplay or storytelling to engage children, along with pamphlets or posters for reinforcement. The outreach successfully fostered awareness about legal rights and encouraged community members—especially women—to take a proactive role in asserting and protecting those rights. The program underscored how legal empowerment can serve as a transformative force in economically challenged neighborhoods.

Outreach Session on Padhega Bharat, Tabhi Toh Badhega Bharat at Civil Lines Kanpur. 30th July 2024

In collaboration with Vishwanath Sharan Foundation

In collaboration with the Vishwanath Sharan Foundation, this outreach initiative focused on education and empowerment under the banner “Padhega Bharat, Tabhi Toh Badhega Bharat.”

The event targeted young students, particularly girls, educating them on scholarships, government schemes, and cybersecurity. The session began with a detailed overview of various scholarships and their eligibility criteria, aiming to encourage continued education, especially among underprivileged girls. Cybersecurity tips were also shared to protect students from online threats.

A highlight of the session was an interactive discussion on the value of education, which saw enthusiastic participation. Girls were especially encouraged to see education as a tool for empowerment. Devanshi attended in person, and her presence lent a personal touch, while others joined remotely to assist. The outreach was impactful, seamlessly combining educational access with safety awareness and promoting confidence among the participants to pursue both academic and digital literacy.

Outreach Session on Legal Awareness at SK Children Foundation, Janakpuri

30th July 2024

The final outreach conducted at the SK Children Foundation in Janakpuri, in collaboration with the Prayan Foundation. The session focused on gender equality and general awareness about India's legal system. The young attendees—mostly children—were introduced to fundamental rights, gender identity, and gender-based laws through interactive and age-appropriate discussions.

The facilitators explained key legal concepts like dowry laws, child rights, and the structure of India's judiciary. A highlight of the session was the explanation of Lok Adalats, which fascinated the children and helped them understand how justice can be delivered in a more accessible and friendly way. The topic of gender resonated deeply, especially when explained through real-life stories. Children who had witnessed gender discrimination in their communities responded with curiosity and empathy. The session also introduced them to historical figures like Dr. B.R. Ambedkar, and his contributions to the Constitution, giving them context on how laws are shaped.

Overall, the session aimed to empower children with knowledge about their rights and responsibilities as citizens. The facilitators noted the children's enthusiasm and concluded that legal education—even at an early age—can have lasting impact. The outreach left the students feeling informed and empowered.

Outreach Session on POSCO at VSF Foundation, New Delhi

30th July 2024



The session focused on educating children about their rights and the legal safeguards offered under the Protection of Children from Sexual Offences (POCSO) Act. Ms. Gupta began by introducing fundamental child rights enshrined in the Indian Constitution, including the right to education, protection from exploitation, and personal safety. A major emphasis was placed on the POCSO Act, where she explained key provisions such as the types of offenses covered, the importance of timely reporting, and the legal protections available to child victims. The session was highly interactive, encouraging children to voice their concerns and ask questions in a safe and supportive environment.

The participants were guided on recognizing inappropriate behavior, how to respond to abuse, and where to seek help—be it from parents, teachers, or legal authorities. The session was well-received and succeeded in fostering awareness and confidence among the children regarding their rights and personal safety.

Legal Awareness Drive at Amberhai Village 21st & 22nd September 2024



On 21st September 2024, Guru Gobind Singh Indraprastha University, through its Centre for Outreach and Extension Activities, conducted a significant awareness drive in Amberhai village under the Community Outreach Program. The event aimed to educate locals about vital government welfare schemes such as Ayushman Bharat, Pradhan Mantri Suraksha Bima Yojana, Old Age Pension, and more. Led by Prof. Vandana Singh, Dr. Zubair Ahmed Khan, and student convenor Harmeet Singh, a team of over 40 GGSIPU students and researchers engaged with villagers door-to-door.

They explained eligibility criteria, application procedures, and even offered help with documentation. A recurring issue that emerged was the lack of Aadhaar documentation, which was preventing many from accessing these benefits. The students not only provided awareness but also guided residents in navigating bureaucratic hurdles. The experience was transformative for both students and villagers, shedding light on socio-economic gaps and highlighting the importance of grassroots legal and welfare awareness. The initiative was successful in bridging critical knowledge gaps and brought university learners closer to real-world community engagement.

Mobile Dental Clinic at Mundhela Village

25th September 2024



On 25th September 2024, the Guru Gobind Singh Indraprastha University launched its “Reaching the Unreached” initiative under the Dilli Gramodyay Abhiyan with a Mobile Dental Health Clinic visit to Mundhela Gaon, Najafgarh. Inaugurated by Shri Vinay Kumar Saxena, the Lieutenant Governor of Delhi, and led by Vice Chancellor Prof. Mahesh Verma, the event offered free dental care services to an underserved population.

Key organizers included Prof. Vandana Singh, Dr. Zubair Ahmed Khan, Dr. Tara Chand, Dr. Nikita Sharma, and Harmeet Singh. The camp offered oral check-ups, cleaning, fluoride treatments, temporary fillings, and extractions. Around 40-50 villagers attended and received both care and education about dental hygiene. Educational sessions were conducted to stress the importance of oral health, brushing techniques, and preventive habits.

This was the first time a mobile dental clinic had reached the village, and the gratitude expressed by residents reflected its success. The initiative not only addressed immediate dental issues but also laid the foundation for sustained oral healthcare awareness. By integrating education and treatment, the event fulfilled its dual objectives of alleviating pain and promoting long-term oral health practices.

Mobile Dental Clinic at Dichaon Kalan village

9th October 2024



On 9th October 2024, the Mobile Dental Health Clinic under the “Reaching the Unreached” initiative visited Dichaon Kalan village. Organized by Guru Gobind Singh Indraprastha University with support from Maulana Azad Institute of Dental Sciences and E.S.I.C Dental College, the event continued the goal of offering free and accessible dental care to rural communities.

A total of 41 patients were screened, with 18 receiving treatment and 34 provided with medications. Services included routine dental check-ups, extractions, scaling, and fluoride applications. Oral health education was a core component, with villagers being taught proper brushing techniques and preventive care routines. The local ASHA worker, Ms. Shakuntala Devi, stressed the urgent need for more frequent dental camps due to the lack of affordable care options under the CGHS panel.

Positive feedback from villagers affirmed the impact of the initiative, especially since many had never had access to such specialized services before. The team’s efforts reflected GGSIPU’s commitment to combining service delivery with community empowerment through health literacy.

Mobile Dental Clinic at Samaspur Khalsa Village

23rd October 2024



Continuing its mission of delivering dental healthcare to rural populations, the “Reaching the Unreached” Mobile Dental Health Clinic arrived at Samaspur Khalsa on 23rd October 2024. This marked the first visit of a mobile dental unit to the village. The clinic, operated by Guru Gobind Singh Indraprastha University in partnership with local health institutions, screened 32 patients, treated 21, and provided medication to 16.

The services included comprehensive dental examinations, cleanings, temporary fillings, and extractions. Much emphasis was placed on raising awareness about oral hygiene practices and dietary habits that contribute to dental health. Villagers, many of whom were receiving professional dental care for the first time, expressed their appreciation for the timely assistance.

This event further exemplified the university’s commitment to improving the health outcomes of remote and underserved communities through strategic and sustained interventions. The session also emphasized the importance of regular check-ups and early intervention, helping to embed a culture of preventive care among the local population.

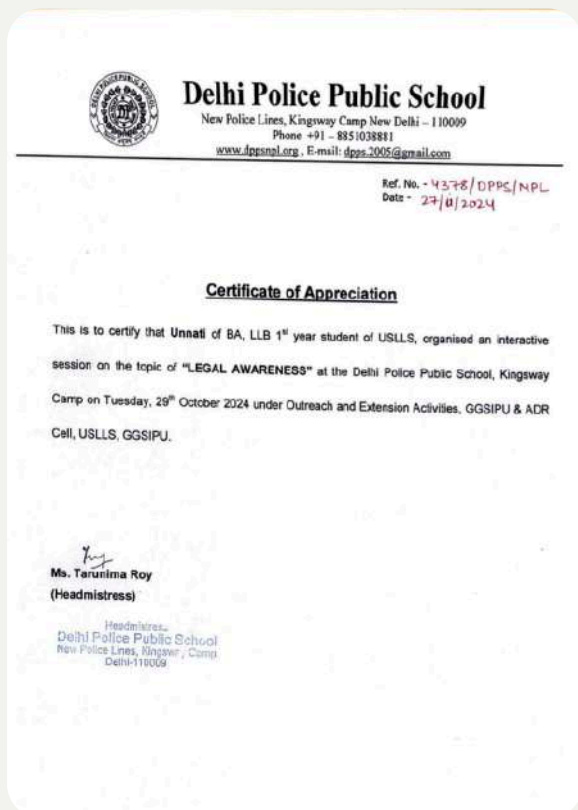
Outreach Program at Sarvodaya Vidyalaya, Dwarka, Sector 17 28 October 2024



Tamanna Bhardwaj, Nikita Balayan, and Meghna Suresh. This session aimed to introduce school students to fundamental concepts of law, its role in society, and legal career prospects. Organized at Sarvodaya Vidyalaya, Sector 17, Dwarka, the outreach began with a presentation on different career paths in law, including advocacy, corporate law, judiciary, legal academia, and public service. The facilitators highlighted key skills needed to succeed in the legal field, such as analytical thinking and communication. A major theme was the necessity of law in ensuring order and justice, and how it protects individual rights while upholding democracy. The team also discussed the costs and benefits of pursuing legal education and addressed common queries. These included the difference between civil and criminal law, the educational pathway to becoming a lawyer, and the availability of legal aid for economically weaker sections. Students showed a strong interest in the subject, actively engaging in the Q&A session. Teachers appreciated the clarity and relevance of the session, and many students expressed interest in exploring law further. The session effectively sparked awareness and curiosity about law and its social value, making it a successful model for educational outreach.

Outreach Session on Legal Awareness at Delhi Police Public School, Kingsway Camp

Held at Delhi Police Public School, this outreach was divided into two sessions for students of classes 11 and 12, aimed at promoting legal awareness and introducing law as a career option. The first session, led by Palak Goel and Unnati, focused on fundamental rights, the scope of legal studies, and entrance exams like CLAT, SLAT, and LSAT. The second session, conducted by Tripti Rohilla and Prachi Dhangar, reinforced these themes for the senior-most students. The workshop covered core legal concepts, the significance of studying law, and diverse career avenues available in the field, such as litigation, judiciary, and corporate law. The event featured an interactive Q&A session where students asked insightful questions about the differences between lawyers and advocates, CLAT preparation strategies, and how social media can be used to stay informed about legal news. The session concluded with a vote of thanks from Principal Mrs. Tarunima Roy, who highlighted the importance of legal education in shaping socially responsible citizens. Ambedkar SOSE in Yamuna Vihar was a 90-minute interactive session aimed at raising legal awareness and introducing law as a career. The session was divided into three parts: Right to Information (RTI), Free Legal Aid, and Careers in Law. Mansi Sharma led the segment on RTI, explaining its practical applications and how it empowers citizens.

Pranay Sharma spoke about free legal aid, discussing its availability, especially for marginalized groups, and the role of university legal aid cells. They asked about filing RTIs, juvenile justice, cyber laws, and police accountability.

Mobile Dental Clinic at Jharoda Kalan Village

6th November 2024



On 6th November 2024, the Mobile Dental Health Clinic initiative reached Jharoda Kalan in Najafgarh as part of Guru Gobind Singh Indraprastha University's outreach efforts under the Dilli Gramodyay Abhiyan. The event was supported by Shri Vinay Kumar Saxena, the Honorable Lieutenant Governor of Delhi, and Prof. Mahesh Verma, Vice Chancellor of GGSIPU.

Organized by the Centre for Outreach & Extension Activities, the program provided dental services to 49 individuals, with 35 receiving treatment. Services included routine check-ups, preventive scaling, fillings, extractions, and medication distribution. Doctors from ESIC Dental College and GGSIPU, including Dr. Ujjwal Aggarwal, Dr. Tarachand, and Dr. Neetika Sharma, were present alongside officials and interns who ensured smooth functioning.

The community was highly appreciative, noting the rarity of such accessible services in their locality. Educational sessions on oral hygiene complemented the treatments. The collaborative effort with E.S.I.C Dental College, Maulana Azad Institute of Dental Sciences, and local government bodies demonstrated the power of institutional partnerships in addressing healthcare disparities.

Outreach Session on Career prospects in Law at New Era Public School, Dwarka

14 November 2024

At New Era Public School, Dwarka, Neha and Prisha Udar conducted an enriching outreach session aimed at broadening students' understanding of law as a viable and dynamic career path. The program was tailored to both junior (Classes 9 and 10) and senior students (Classes 11 and 12). For the juniors, the facilitators introduced law through engaging anecdotes and real-life examples, challenging the traditional career mindsets dominated by medicine and engineering.

They emphasized law's relevance in society and its role in protecting rights and ensuring justice. For the seniors, the session took a deeper dive into career pathways, covering the structure of legal education in India, including integrated 5-year programs like BA LLB, and entrance exams such as CLAT. They discussed diverse fields within law, including corporate, cyber, environmental, and entertainment law, highlighting the vast opportunities available.

Students were highly engaged and asked insightful questions about exam preparation, life in law school, and the scope of legal professions. The interactive format and relatable presentation helped demystify law and encouraged students to consider it as a meaningful and impactful career. The session was well-received and succeeded in making legal studies more accessible and appealing to young minds.

Mobile Dental Clinic at Mundhela Village

20th November 2024



Returning to Mundhela Kalan on 20th November 2024, Guru Gobind Singh Indraprastha University's mobile dental team continued its "Reaching the Unreached" campaign. The second camp at this location reinforced ongoing care and focused on awareness and treatment for oral health issues. A total of 41 patients were screened, 32 treated, and 11 received Sensodyne toothpaste to promote continued dental hygiene. Services included fillings, cleanings, extractions, and the distribution of medicines.

Awareness sessions were held using pamphlets and demonstrations of brushing techniques to help villagers adopt preventive habits. Feedback was encouraging, with community members expressing satisfaction with the service quality and accessibility. Some requested regular follow-up camps, reflecting the growing trust and dependence on the initiative. GGSIPU's approach of combining treatment with education ensured that the outreach had both immediate and lasting impacts. This event not only reinforced the university's dedication to rural healthcare but also highlighted the importance of sustained community engagement to build long-term health resilience.

Outreach Session on Bullying at PM Shri Kendriya Vidyalaya MIRC, Ahmednagar

22 November 2024

This online outreach session, conducted by Mehak Soni and Shivya Bhagat, focused on educating 9th-grade students of PM Shri KV MIRC, Ahmednagar, on children's rights, responsibilities, and legal careers. 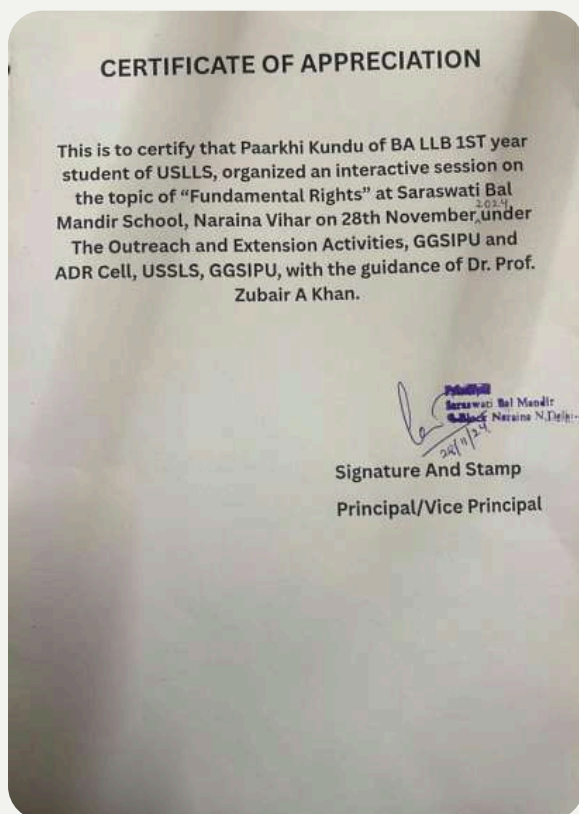

28 November 2024



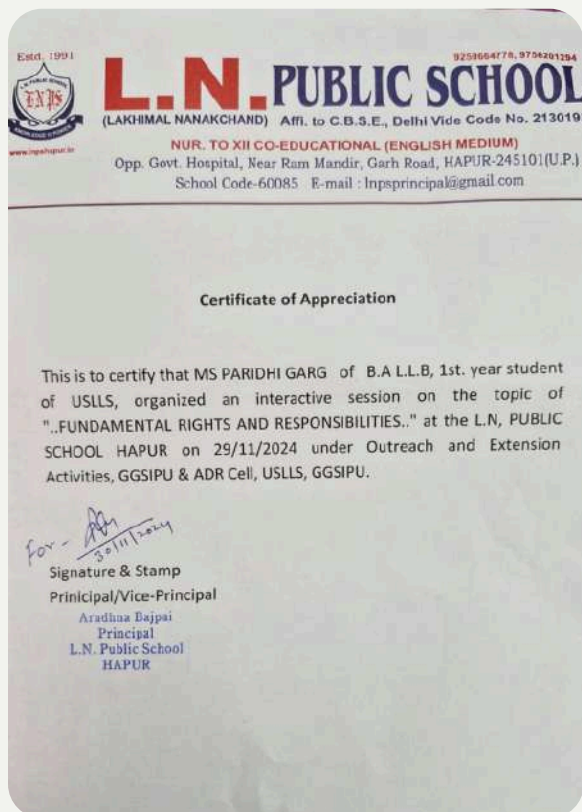

29 November 2024

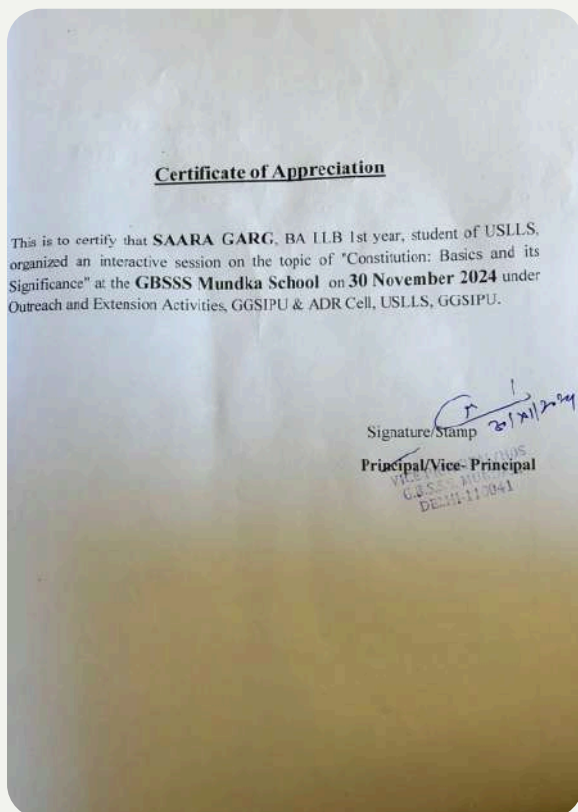

Outreach Session on Decoding Cyber Crime at Adarsh Shiksha Niketan Sr. Secondary School, Mayur Vihar

30 November 2024

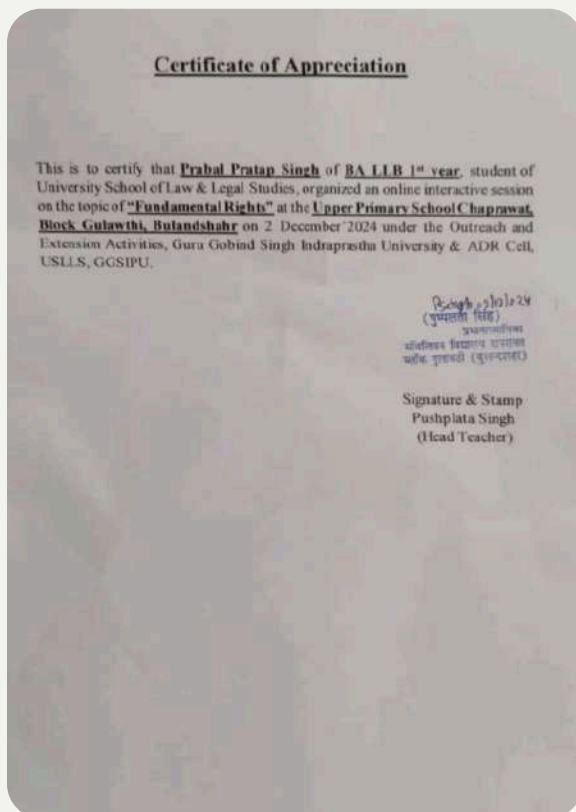

Omisha Sharma organized and led an online session titled “Decoding Cyber Crime” at ASN Sr. Secondary School, Mayur Vihar, under the Outreach and Extension Activities of GGSIPU. Conducted via Google Meet due to GRAP-4 restrictions, the 75-minute session was attended by Class 11 students and a faculty convener. The session was divided into three main segments: an overview of cybercrime, cybersecurity and prevention techniques, and relevant cyber laws in India. Omisha explained the origins of cybercrime, its exponential rise, and its wide-ranging impact on individuals, particularly teenagers.

She discussed practical cyber hygiene tips, such as password protection, recognizing phishing attempts, and not oversharing on social media. The legal framework was explained through the IT Act, 2000, the IT Rules, 2021, and the Cybersecurity Framework, with emphasis on legal remedies for victims. A highlight of the session was a quiz-based icebreaker, followed by an engaging Q&A, where students asked questions on topics like cyberbullying, privacy breaches, and identity theft. Despite being conducted online, the session received strong participation and was deeply appreciated by students and faculty alike. It succeeded in sensitizing young learners about their digital rights and responsibilities, reinforcing the need for cyber-awareness in today’s connected world.

Outreach Session on Legal Awareness at Upper Primary School, Chaprawat

2 December 2024

This outreach session conducted by Shavez Ansari and Prabal Pratap Singh targeted students from classes 6 to 8 at Upper Primary School, Chaprawat, with the objective of fostering early legal awareness through education on Fundamental Rights. The duo presented the six primary rights—Equality, Freedom, Protection from Exploitation, Freedom of Religion, Cultural and Educational Rights, and Constitutional Remedies—using charts, posters, and interactive discussions. Real-life examples helped students relate to abstract legal principles, and group discussions allowed them to voice personal experiences where these rights could apply. Students responded with enthusiasm, asking questions and participating in the interactive elements of the program.

14th February 2025



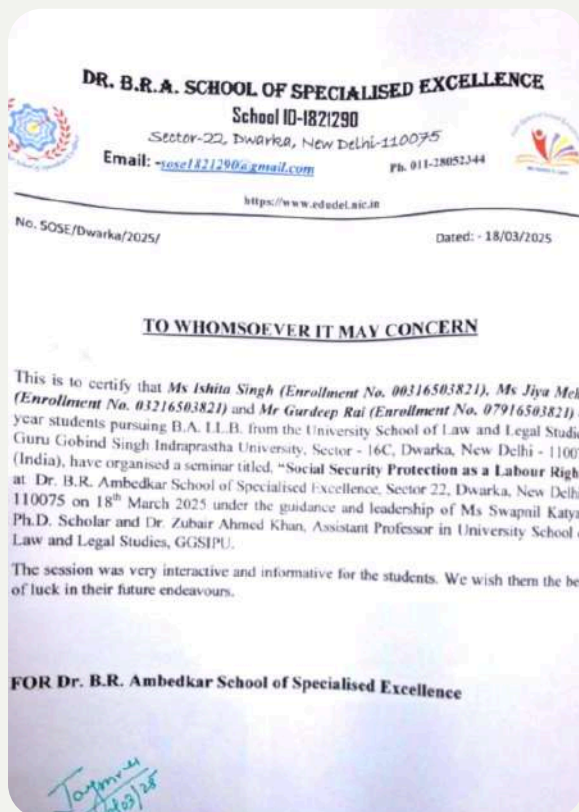

Seminar on Social Security Protection as a Labour Right

This seminar, conducted by USLLS students Ishita Singh, Jiya Mehta, and Gurdeep Rai, aimed to educate school students about the importance of social security as a fundamental labour right. The session opened with a short documentary titled "Anuja," which introduced key themes in an accessible format. The students then presented a comprehensive overview of legal frameworks such as the Employees' State Insurance Act, the Employees' Provident Fund Act, and the Unorganised Workers' Social Security Act. They also discussed relevant international conventions and judicial interpretations that reinforce workers' rights in India.

The session was highly interactive, with students asking thoughtful questions and sharing insights about their own families' experiences. Presenters guided them through the significance of workplace protections and how they could advocate for labour rights.
