IN THIS REGARD, ALL THE NEET UG 2025 QUALIFIED CANDIDATES ARE HEREBY INFORMED THAT THE UNIVERSITY IS CONDUCTING THE EXTENDED STRAY VACANCY ROUND II THROUGH CENTRALIZED ONLINE COUNSELLING FOR BAMS (CODE 153) & BHMS (CODE 154) PROGRAMME (SUBJECT TO AVAILABILITY OF SEATS) FOR THE ACADEMIC SESSION 2025-26 ON 09.12.2025.

ALL THE CONCERNED MUST REFER TO THE SCHEDULE AS FOLLOWS:

CRITERIA FOR PARTICIPATION IN EXTENDED STRAY VACANCY ROUND II ONLINE COUNSELLING:

- THERE WILL BE NO FRESH REGISTRATION/ CHOICE FILLING IN THIS ROUND. THE CHOICES SUBMITTED DURING SVR-I WILL BE CONSIDERED FOR EXTENDED STRAY VACANCY ROUND II.
- REGISTERED CANDIDATES WHO HAVE SUBMITTED CONSENT FOR STRAY VACANCY ROUND I AND HAVE NOT BEEN ALLOTTED ANY SEAT (THROUGH STATE/CENTRAL/AIQ ACROSS THE COUNTRY).
- IF A CANDIDATE IS ALLOTTED A SEAT IN THIS ROUND, HE/SHE HAS TO JOIN THE ALLOTTED SEAT/COLLEGE.

WHO ARE NOT ELIGIBLE FOR ALLOTMENT:

- CANDIDATE ALLOTTED/HOLDING ANY SEAT (THROUGH STATE/CENTRAL/AIQ ACROSS THE COUNTRY).
- CANDIDATES ALLOTTED A SEAT IN STRAY ROUND I AND DID NOT FOLLOW THE REQUIRED PROCEDURE i.e. PAYMENT OF PART ACADEMIC FEE OF RS. 96000/-, REPORTING AT THE ALLOTTED COLLEGE.

Candidates allotted seats will be required to join the allotted college/course within stipulated time which is mentioned in counseling schedule. If a candidate is allotted a seat in Stray round, he/she has to join the allotted seat/college. If the candidate does not join the allotted seat, his/her entire deposit fee will be forfeited and the candidate will not be eligible to participate in further rounds, if any.

IMPORTANT NOTE:

- 1) RESULTS MUST BE CHECKED BY THE CANDIDATE THROUGH HIS/HER ACCOUNT LOGIN. NO PERSONAL INTIMATION WILL BE COMMUNICATED TO THE CANDIDATE IN PERSON OR THOROUGH MAIL.
- 2) THE ELIGIBILITY ALONG WITH CLAIMED RESERVED CATEGORY DOCUMENTS SHALL BE VERIFIED BY THE AUTHORITY OF THE RESPECTIVE ALLOTTED COLLEGE/INSTITUTE PRIOR REPORTING.
- 3) FOR ENSURING FAITHFUL OBEDIENCE OF TIME SCHEDULE AND ALSO KEEPING IN VIEW THE LIMITED TIME AVAILABLE FOR CONDUCTING COUNSELLING, ALL PARTICIPATING INSTITUTES/COLLEGES ARE DIRECTED TO TREAT ALL SATURDAYS/ SUNDAYS AND GAZETTED HOLIDAYS AS WORKING DAYS.
- 4) AFTER THE ALLOTMENT OF SEAT, THE CANDIDATES WILL HAVE TO PAY THE PART ACADEMIC FEE AS MENTIONED IN THE TABLE ABOVE TO CONFIRM THE ALLOTMENT, FAILING WHICH, THE CANDIDATE WILL LOSE HIS/HER CLAIM TO THE ALLOTTED SEAT.
- 5) CANDIDATES ARE REQUESTED TO MANDATORILY REPORT ON THE ABOVE DATE.

WITHDRAWAL AND FEE REFUND AFTER THIS ROUND OF COUNSELLING: Candidates are not allowed to withdraw/resign from their allotted seat. No representation for refund of fee in this matter will be entertained by the University.

The candidates are required to mandatorily report and join the respective colleges/institutions with the Provisional Allotment Letter and the necessary record for verification of documents at the college and pay the balance amount of fees (if any), as per the schedule mentioned above.

All admissions shall be provisional till regularized by the University. **PROVISIONAL ADMISSION WILL NOT BE DONE FOR ANY RESULT AWAITED OR COMPARTMENT / SUPPLEMENTARY CASES.**

THE INSTITUTIONS SHALL SUBMIT DATA OF THE JOINED CANDIDATE (AS PER NIC ONLINE PORTAL) TO THE UNIVERSITY: Institutes are required to submit a certificate within two days to the Admission Branch after the reporting schedule of a particular Round of counseling stating that all documents (i.e. qualifying exam eligibility, reserved category certificate, CET score card) of allotted candidates in their USS/Institute have been verified and they are found eligible (including remaining part academic fees) and thereafter all the candidates after a particular round of counselling have been shown reported on the NIC portal by the concerned USS/Institute and that there is not even a single Student being allowed to attend classes who has not been allotted any seat after a particular round of counselling.

REITERATED THAT THE ALLOTMENT IS MADE BASIS ON THE CLAIMED CATEGORY AND REGION. DOCUMENTS WILL BE CHECKED SUBSEQUENTLY IN THE RESPECTIVE ALLOTTED AFFILIATED INSTITUTE. SEAT ALLOTTED DUE TO WRONG REGION / DEFICIENCY REGARDING VALIDITY IN RESERVED CATEGORY DOCUMENTS WILL BE CANCELLED AND THE CANDIDATE WILL LOOSE HIS/HER CLAIM ON THE ALLOTTED SEAT WITH FORFEITURE OF FEE.

RESERVED CATEGORY CANDIDATES WHOSE DOCUMENTS ARE NOT IN ORDER WILL FORFEIT HIS/HER RIGHT FOR THE RESERVED CATEGORY ENTITLEMENT AND WILL AUTOMATICALLY BE CONVERTED TO GENERAL CATEGORY AS PER UNIVERSITY RULES. HIS/HER ALLOTTED SEAT SHALL STAND CANCELLED AND THE FEE SHALL BE FORFEITED.

The University will not be responsible for network problems or any other problem of such nature for any activity during the last minute.

It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the programmes they seek admission; the correctness of the details filled with respect to region; Category/Sub Category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or false, the admission to the such programme shall be cancelled and all the fees paid will be forfeited.
