EXTENSION OF SPECIAL ROUND OF OFFLINE COUNSELLING -- "VERIFICATION OF DOCUMENTS' & 'ALLOTMENT OF SEATS' THROUGH THE MERIT OF CUET FOR THE PROGRAMMES MBA, BBA & ALLIED PROGRAMMES / 5 YEAR BBA MBA INTEGRATED, BCA, BA(JMC), B.COM, BA ENGLISH AND BA ECONOMICS

- The University vide Notification No. 318/2025 notified the dates of submission of Offline Forms (on 10.9.25 and 11.9.25) for Extended Special Round of Counselling on the basis of CUET Merit for various UG and PG Programmes. This opportunity was given to the leftover candidates who, somehow, could not register on online portal.
- 2. The University hereby notifies the Schedule for 'Verification of Documents' and 'Allotment of Seats' during the Extended Special Round of Offline Counselling to fill up the seats remained vacant pursuant to conclusion of 'Special Round of Offline Counselling'.
- 3. The Schedule for "Extended Special Round of Offline Counselling" for the following programmes is given:

- 4. The Extended Special Round of Offline Counselling will be conducted only for the "NOT ADMITTED" candidates in various Programmes. It is stated that the candidates should not be in possession of a seat (in that particular programme where one is desirous of seeking admission). Candidates applied for withdrawal in offline mode after 25.08.2025 will NOT BE TREATED as "NOT ADMITTED" candidate. Candidates who have already taken admission in the Management Quota in affiliated Institute/College shall not be considered in the Extended Special Round of Offline Counselling.
- 5. Documents required at the time EXTENDED SPECIAL ROUND OF OFFLINE Counselling:
  - a. Demand Draft/Bank Draft(s) of Rs. 96,000/- towards Part Academic Fee is required, WHICH IS MANDATORY at the time of counselling in favour of "Registrar, Guru Gobind Singh Indraprastha University", payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme, CUET Merit Rank and CUET Application Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted institute at the time of reporting in the college.

NOTE: THE FEE OF Rs. 96000/- IF PAID DURING THE COURSE OF ONLINE COUNSELLING PROCESS SHALL NOT BE ADJUSTED IN THIS ROUND. THE FEE PAID EARLIER WILL BE REFUNDED SEPARATELY. HENCE, IT IS MANDATORY TO BRING THE DEMAND DRAFT FOR OBTAINING SEAT IN THIS ROUND OF COUNSELLING.

- Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- 6. During the course of Extended Special Round of Offline Counselling, the allotment of seats shall be carried out irrespective of Region and Category on All India basis. Allotment of seat shall be done on the basis of CUET. It is reiterated that remaining seats will be offered to the CUET candidates in the order of merit. A consolidated Merit List, [(i) from among the candidates who had registered earlier on NIC portal but did not take admission, and; has 'Not Admitted' status, and (ii) freshly registered by submitting offline form] will be displayed on the University Website on 12.9.25.
- 7. The conduct of the Extended Special Round of OFFLINE Counselling is to facilitate those candidates only who had registered earlier online but had not opted a seat AND to the candidates who have applied in offline mode on 10.9.25 and 11.9.25.
- 8. Physical presence of the candidate is mandatory at the time of Offline Counselling, except for medical reasons.
- 9. Any candidate who had secured any seat in any programme/college through NLT/CET/CUET of the University and has "ADMITTED STATUS" shall not be granted any seat in any programme through the merit of CUET.

The Candidate who have taken admission in Special Round of Offline Counselling or through the Special Entrance Test (SET) merit shall be treated as "ADMITTED" (even if they had not reported to the allotted college and even withdrawn from their seat).

- 10. College once allotted in this Round of Counselling will not be changed subsequently.
- 11. It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requisite eligibility and qualifications prescribed for admission in a particular course.
