IMPORTANT NOTICE FOR ADMISSION IN POSTGRADATE AYURVEDA COURSES (THROUGH AIAPGET 2025) ROUND 02 OFFLINE COUNSELLING 2025-26

DETAILED SCHEDULE REGARDING 2ND ROUND OF OFFLINE COUNELLING (FOR 50% GGSIPU INSTITUTIONAL QUOTA SEATS) FOR VERIFICATION OF DOCUMENTS AND ALLOTMENT OF SEAS IN THE PROGRAMME PGAC (MD/MS AYURVEDA) (CODE 196) IN CH. BRAHM PRAKASH AYURVED CHARAK SANSTHAN, NEW DELHI (AFFILIATED TO GGSIP UNIVERSITY) FOR THE ACADEMIC SESSION 2025-26

This information notice is being notified for admission under 50% State/Institutional Quota seats in MD/MS Ayurveda only for candidates who have passed BAMS degree from GGSIP University.

The procedure for "Verification of Documents" and "2nd Round of Offline Counselling/Allotment of seats" for the 50% State/Institutional Quota seats for the above said programmes is given below:

1. Only the candidates who have qualified AIAPGET 2025 and have passed BAMS from GGSIP University, have registered with this University and submitted their documents for verification and preparation of merit list are only eligible to participate in this Offline Counselling for 50% seats under State/Institutional Quota.

It may please be noted that the candidates who have not qualified AIAPGET 2025 and have not registered with GGSIPU or did not submit their documents for verification and preparation of merit on the specified date & time, are not eligible to participate in the counselling for allotment of seats.

2. Merit list prepared basis on the documents submitted by the registered candidates, is already uploaded on the University website along with University notification no. 350/2025 dated 23.09.2025 followed by Updated Merit List for Academic Session 2025-26.

3. The tentative vacant seat status to be filled in Round 02 offline counselling under 50% State/Institutional Quota is as under:

The final vacancy status (with changes, if any) shall be displayed at the venue on the day of counselling/ allotment of seats.

4. The candidate has to be present in person for the purpose of verification of documents and allotment of seats as per the schedule on the specified date & time. The candidate must produce original certificates for the purpose of verification of documents and allotment of seats.

5. **SCHEDULE FOR 2ND ROUND COUNSELLING UNDER 50% STATE/INSTITUTIONAL QUOTA:**

In case of vacancy arising after the 1st round of counselling, the following procedure will be adopted:

1ST PHASE OF ALLOTMENT OF SEAT:

From the allotted seats, from whatever roster point, the vacancy has arisen, in any particular category, then the seat shall be offered to the same eligible candidate merit rank-wise till all eligible candidates are exhausted, after which the conversion of seat shall be done as per norms. The 1st phase of 2nd round of counselling will start from the roster point at which the last seat was allotted in the relevant stream i.e. Dravyaguna Vigyan.

2ND PHASE OF ALLOTMENT OF SEAT:

The resultant vacancy (ies) so created after the allotment of 1st phase of 2nd round of counselling shall be offered to the registered candidates who had not opted or allotted any seat during the 1st round of counselling and also, those registered candidates who were absent on the day of allotment of seat in 1st round of counselling but his/her name figures in the Merit List uploaded on the University website.

6. **SCHEDULE FOR COUNSELING/ALLOTMENT OF SEAT:**

Note:

- (1) Only the registered candidates who have passed qualifying examination i.e. BAMS from GGSIP University and submitted their documents for verification and preparation of merit list within the scheduled date & time are eligible to participate in the Offline State/Institutional Quota counselling.

- (2) All the candidates, irrespective of Rank and Category, have been called to ensure that no seat remains vacant. However, THE COUNSELING SHALL STOP AS AND WHEN THE SEATS ARE FILLED UP.

7. ROSTER POINT:

The roster shall be continued from the next roster point, where the 1st round counselling was closed in the Academic Session 2025-26 after allotment of seat in the relevant stream i.e. Dravyaguna Vigyan in the 1st phase of Round 02 counselling. However, candidates are advised to read the procedure for conduct of Round 02 counselling detailed in the schedule above.

Note: Since the roster point cannot be left blank, the conversion of seat of a category will be during the first counselling itself. The EWS seats will be filled purely on merit and on the roster system during allotment of seats. There shall be no OBC reservation in PGAC. Refer Admission Brochure 2025-26.

8. FOR ELIGIBILITY, QUALIFYING MARKS/ CUT OFF PERCENTILE:



9. DOCUMENTS REQUIRED AT THE TIME OF COUNSELLING/ADMISSIONS:

- i) Passport size photographs-4 nos.
 - ii) Demand Draft of Rs. 96,000/- in favour of 'Registrar, Guru Gobind Singh Indraprastha University', payable at Delhi.
 - iii) AIAPGET Score Card 2025
 - iv) Appendix 6 – Admission Verification Form, as available in the Admission Brochure 2025-26 (to be filled up by the candidate) – Original
 - v) Preference Sheet (to be filled up by the candidate) –Original
 - vi) 10th Class Certificate as proof of date of birth
 - vii) BAMS/BHMS Degree from GGSIPU / Provisional Certificate
 - viii) Detailed marksheets of qualifying examinations – All Professional examination of BAMS/BHMS
 - ix) Proof of passing the compulsory rotating internship completion certificate as per the NCISM/NCH notification (for the academic year 2025-26 only)
 - x) Permanent or Provisional Registration Certificate issued by the CCIM/ NCISM/CCH/ NCH/ State Medicine Board
 - xi) Reserved Category Certificate (EWS/SC/ST/PWD) duly issued by the Competent Authority, as applicable.
 - xii) Character Certificate from Head of the Institution from where the qualifying examination was passed (should not be less than 06 months old).
 - xiii) Employer's certificate and an NOC, if employed.
10. All the candidates allotted in the 2nd round of counselling shall report in the allotted college latest by 20th December, 2025. The fee will be forfeited if a candidate does not join the Round 02 allotted seat or surrender/withdraw the Round 02 seat. Further, the fee will also be forfeited if the allotted seat is cancelled due to any unforeseen reason from the candidate's end.


Important Note: Any other terms and conditions as defined by the Statutory body/Competent Authority, shall be applicable for counselling/ admission process.
