### THE ORGANISER

Samadhan, the Delhi High Court Mediation Conciliation Centre, was established in May 2006 to promote mediation as a method of alternate dispute resolution. It is managed by a team of trained mediators from the Delhi High Court Bar Association, overseen by a panel of judges and advocates. The Centre handles both court-referred and pre-litigation covering areas like business contracts, estate, and consumer real matrimony, Samadhan has resolved over 300 cases in its early years, helping settle more than 400 related cases. Its infrastructure has expanded with additional rooms and video conferencing facilities to accommodate growing demand. The Centre conducts training programmes for new/mediators and maintains a panel of experts to assist with complex disputes. Samadhan has gained recognition as a leading mediation centre, with over 80 matters listed daily. 265+ mediators contribute to its success, which is supported by the judiciary and the public. The Centre has been instrumental in changing perceptions of conflict resolution. Samadhan continues to be a model for effective dispute resolution in India.

The National Legal Services Authority in association with the Mediation & Conciliation Project Committee, Supreme Court of India has conceptualizes the special, "Mediation for the Nation", campaign. This certified 40-hour mediation training programme, organised in collaboration with Samadhan – the Delhi High Court Mediation and Conciliation Centre, is particularly valuable for law graduates and young professionals aspiring to build a career in mediation, offering them a credible and robust platform to develop expertise in this specialised field.

The programme will also provide an enabling environment for networking and professional exchange, encouraging participants to share insights, experiences, and perspectives that enrich the collective learning process.

Upon successful completion, participants will acquire both a strong expertise in the principles of mediation and the practical competencies necessary to apply these skills effectively in legal and professional contexts.
