Guidelines for Research Publication Grant-2024

I. Introduction

One of the fundamental objectives of any University is not only to impart knowledge through its teaching programmes, but also to generate knowledge through its research programmes and to train research scholars in the rigour of knowledge production. It is predominantly measured as research articles in reputed, peer reviewed high impact journals indexed in globally recognized databases. This necessitated publication grants, as many journals charge heavy fees for colour figures, page charges or article processing/publication charges. Following many institutions around the world, Guru Gobind Singh Indraprastha University instituted a mechanism in 2014 to support its faculty members with publication grants. The present guidelines build on its experience to further promote quality research with measurable research output in all disciplines of study in the University Schools of Studies and Centre(s) of Excellence established under Ordinance 35 of the University.

II. Title:

The Guidelines shall be called the "Guidelines for Research Publication Grant- 2024".

III. Objectives:

- a. To encourage faculty members to publish research papers in reputed journals as admissible under these Guidelines.
- b. To grant financial assistance to faculty members for research publications in reputed journals indexed in Web of Science or Scopus as admissible under these Guidelines.
- c. To enhance research output and research visibility of the University in all disciplines of study.
- d. To maintain an encouraging and enabling eco-system for research in the University.
- e. To encourage publicly funded research output to become freely accessible to the general public.

IV. Applicability:

These guidelines shall be applicable from the date of their notification.

V. Eligibility for Publication Grant:

- a. The faculty members on the regular employment of the University in University Schools of Study (USS) or Centre(s) of Excellence established under Ordinance 35 of the University (CoE) (including those on probation) shall be eligible for grant of financial assistance for research publications in journals as admissible under these Guidelines for publishing research work done primarily at the University (including collaborations outside USS/CoE).
- b. The regular faculty members on deputation to other institutions shall be eligible for grant for only such publications which pertains to work done from G.G.S. Indraprastha University and identifies their association with the University.
- c. The faculty members on deputation to the University or associated with the University as adjunct faculty or employed with the University on tenure basis shall also be eligible for grant if the research publication pertains to work done from G.G.S. Indraprastha University and identifies their association with the University.

VI. Admissibility for Publication Grant:

Research publications as specified below shall only be admissible for the grant of financial assistance by the G.G.S. Indraprastha University under these Guidelines:

- a. The financial assistance for research publication shall be admissible only if it is a declared and notified policy of the journal to charge from the authors the publishing cost of one or other kind.
- b. It is mandatory that the first or corresponding author of the concerned research publication for which financial support is being sought from G.G.S. Indraprastha University should be a registered student or the regular faculty of USS/CoE, regardless of whether the remaining authors belong to USS/ CoE or are collaborators from institutions outside USS/CoE. This includes situations wherein the first author or corresponding author from USS/ CoE is clearly identified in the publication as 'equal contribution' or 'co-corresponding author'.

- c. In case of collaborative research work involving institutions outside __the_USS/CoE,_including industrial_collaborations,_wherein_the_faculty member of USS/CoE should be either the first author or the corresponding author in the research article, and there are other authors from other institutions also, the share of G.G.S. Indraprastha University will not exceed 50% of the total publication cost being charged by the journal for publication of the research article.
- d. For the applicants from the USS/CoE of disciplines of Science, Technology, Engineering, Medicine and Management, the funding shall be restricted to one research article per faculty per financial year in reputed, peer-reviewed journal(s) indexed in Web of Science or Scopus with an impact factor of 2 or cite score of 3 or above.
- e. For the applicants from the USS of disciplines of Law, Humanities, Social Sciences, Mass Communication and Education, the funding shall be restricted to one research article per faculty per financial year in a reputed, peer-reviewed journal(s) indexed in Web of Science or Scopus with an impact factor of 0.5 or cite score of 1.0 or above.
- f. For interdisciplinary inter-USS/CoE collaborative research work, the discipline of the first author shall define the category of the applicant.
- g. The impact factor/cite score based on indexing in only the globally recognized databases, i.e Web of Science or Scopus, shall be considered. The applicant shall provide evidence for the same.

VII. Procedure for application:

- a. The faculty shall submit the request for financial assistance under this scheme, through the Dean of the concerned USS/Director of the concerned CoE to the office of Director, Research & Development Cell (RDC) in the prescribed format.
- b. The form must be accompanied by all relevant documents, including proof of acceptance of the research article, /or a copy of the

accepted research article, clearly showing the address of all authors, including first author(s)/corresponding author(s) from USS. Proof of impact—factor/cite—score—based on indexing in only the globally recognized databases Web of Science or Scopus should also be provided.

c. The office of RDC shall submit the completed application form along with all documents to the finance and accounts branch of

the University for payment.

d. The finance and accounts branch of the University shall make direct payment to the publisher or reimbursement to faculty (as the case may be) within a week of receiving the file in the accounts and finance branch.

VIII. General Conditions:

a. The authors, being the best judge & in best position, are expected to choose the best journal in terms of content, target readers, quality

and impact.

b. Under these guidelines, the University shall provide financial assistance for publishing costs or page charges or colour printing charges (inclusive of all taxes and foreign currency exchange charges), only when it is an essential publishing policy of the journal as mentioned on the journal website.

c. The University shall not provide the financial assistance wherein the payment is only an option provided to the authors to make their

article open access in Subscription / Hybrid - mode Journals.

d. The University shall provide financial assistance for the publication of only research article, and not abstracts, book reviews, news & views, perspectives, opinions, popular articles, letters to editor or

conference proceedings.

e. The financial assistance under these guidelines shall be permitted, if the journal itself is called proceedings or based on periodical proceedings of reputed conferences /seminars organized/sponsored by internationally acclaimed professional bodies such as IEEE, IUPAP, IUPAC, and indexed in Web of Science or Scopus with impact factor/cite score as mentioned in 'Admissibility for Publication Grant' clause above.

f. Any case of malafide authorship used for the purpose of claiming financial support shall be treated as research as well as financial misconduct, and shall be dealt with in accordance with the relevant policies of the University.

g. The research publication grant shall not be given for publication in fake or predatory journals. It shall be the responsibility of the applicant to ensure that the journal is not fake or predatory in

nature.

h. Any financial assistance from the University (under these guidelines or any other scheme of the University) must be duly acknowledged at the end of the research published article. The faculty may use the affiliation as "G.G.S. Indraprastha University" in the research article.

IX. Notwithstanding anything contained in these guidelines, for any unforeseen issues arising not covered by these guidelines, or in the event of differences of interpretation, the Vice Chancellor may take a decision in consultation with the Director, RDC. The decision of the Vice Chancellor shall be final.
