**OPENING OF CORRECTION/ EDIT WINDOW ALONGWITH FRESH REGISTRATION
IN PARALLEL TO CHOICE FILLING: MBA (CAT) CODE 101**


1. This is in continuation to University's Important Notification No. 31/2025, IPU-7/DI(Academic)/Misc./2025/457 dated 13.05.2025 and Notification No. 26/2025, IPU-7/DI(Academic)/Online Counseling/2025/443 dated 07.05.2025 regarding opening of correction / edit window in parallel to choice filling in programmes Master of Business Administration (MBA) through CAT 2024 for Academic Session 2025-26.
2. **It is to inform to all the stakeholders that Correction/ Edit window alongwith Fresh Registration has been started for admission in programmes Master of Business Administration (MBA) through CAT 2024 in parallel to the Schedule of Choice/ Preference of Colleges/ Stream upto 20.05.2025 (11:00 P.M.).**
3. Candidates are advised to re-check and/or correct/ edit their filled application form specifically their Category, Sub-Category and Region (as per Last Qualifying Examination) for allotment of seat in their claimed Region/ Category/ Sub-Category.
4. It is reiterated, to claim reservation of Defence Category Seat for admission in Programmes MBA through CAT 2024, Candidates are required to mark their Sub Category Defence "YES", Otherwise candidature of aforesaid candidates, who have marked their sub category Defence "NO" will be treated as "General Category Candidate" or "UR" for allotment of seat in Programmes MBA through CAT 2024 for Academic Session 2025-26, OR; they will be considered on merit Only in the college where the seats for Army, Indian Navy or Indian Air Force (specifically) exist. Further, the candidates choosing Defence Category are required to select the 'priority' of Defence they belong to and upload the desired valid appendices / documents.
5. It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the programmes they seek admission; the correctness of the details filled with respect to region; category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or false the admission to the programme shall be cancelled and all the fees paid will be forfeited.
6. **It is imperative to note by all the stakeholders that the ongoing Filling up of Choices/ Preferences is purely on the provisional basis, final sanctioned seat intake may vary leading to addition/ deletion of any choice of college and/or stream.**

7. Candidates are directed to go through the General Important Instructions for claiming the seats earmarked for various Reserved Categories uploaded on University Website vide Notification No. 30/2025, F.No.IPU-7/DI (Academic)/Misc./2025/456 dated 13.05.2025.
8. Rest of the schedule shall remain same for all registered candidates as notified in the earlier Notification no. 26/2025, IPU-7/DI(Academic)/Online Counseling/2025/443 dated 07.05.2025.
