

- 2. All the eligible CET/ PG CUET, Merit qualified candidates for admission to B.Sc. (Environmental Science) shall report in person for Special Extended Open House Counselling for "Verification of Documents" and "Allotment of Seats" at the venue of counselling, as per following Schedule.

Note: Candidates are advised to summit his/her CET/PG CUET score and admit card on the spot at 10.00 AM on 19.09.2025.

#### **Important:**

- 3. Admission will be made strictly on merit basis (Rank-wise) and counselling/admissions will stop when all the seats get filled-up for the particular round. If seats remain vacant, shall be filled by merit of qualifying exam.
- 4. Bank Draft(s) of Rs Rs. 1,23,500/- (One Lakh Twenty Three Thousand Five Hundred Only) for M.Sc. (Environment Management) & M.Sc. (Applied Geoinformatics), in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate must write his/her name, date of admission, phone number, address, mobile number, name of the programme, CUET Rank, and CUET Roll Number on the back of the Bank Draft(s).(Payment only by Demand Draft).

#### <u>Documents Required for Verification and Allotment of Seats (alongwith a set of photocopies):</u>

- a) Four passport sized photographs
- b) CET/ PG CUET Rank Card/Merit Order of CUET-2025 (copy)
- c) CET/PG CUET-2025 Admit Card (in original) 2025.
- d) Filled Admission verification form as per Appendix 6 of Part F of Admission Brochure 2025-26.

- e) Filled Preference sheet as per Appendix 11A of Part F of Admission Brochure 2025-26.
- f) Proof of date of birth (Secondary School Mark-sheet & Certificate) (Original and Photocopy)
- g) Mark-sheets / Certificates of qualifying examination: The candidate will be required to bring the Original certificates/Mark-sheet in original. The mark sheets will be required for preparing the merit, if seats remain vacant.
- h) <u>Physical Fitness Certificate</u>: All the students shall be required to submit a Medical Certificate from a Registered Medical Practitioner as per (As per Appendix 5) of Admission Brochure 2025-26.
- i) Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.
- j) Candidates who had opted for M.Sc. (EM) and M.Sc. (Applied Geoinformatics) but could not complete the application process may also be permitted to take admission during the Special Extended open House counselling on the basis of a valid CUET score by paying registration fee of Rs. 2500/- (Non Refundable)
- 7. It will also be the sole responsibility of the candidates themselves to make sure that they are eligible and fulfill all the conditions prescribed for admission. Before filling-up the verification slip at the time of verification of documents/counselling/allotment of seats, candidate should ensure that he/she fulfils all eligibility conditions as laid down in the respective Admission Brochure for the session 2025-26. If it is found at any stage during the entire period of the programme that the candidate does not fulfill the requisite eligibility conditions, his/her admission will be cancelled and also disciplinary action will be initiated against his/her and entire fee will also be forfeited.

### 8. Withdrawal of Admission:

All the withdrawal application shall be processed in accordance with the Refund Policy 2025-26, as notified in Part-C (Chapter-12) of Admission Brochure 2025-26.
