**MBBS (CODE 103) – SPECIAL STRAY VACANCY ROUND 2025-26**

All the NEET UG 2025 qualified candidates are hereby informed that the University is in process of conducting the Special Stray Vacancy Round through Centralized Online Counselling for MBBS Programme for the Academic Session 2025-26.

All NEET UG 2025 qualified candidates who wish to participate in Special Stray Vacancy Round Centralized Online Counselling must refer to the schedule as follows:

**CRITERIA FOR PARTICIPATION IN SPECIAL STRAY VACANCY ROUND ONLINE COUNSELLING:**

- THERE WILL BE FRESH REGISTRATION/CHOICE FILLING FOR SPECIAL STRAY VACANCY ROUND.
- CANDIDATE WHO HAVE REGISTERED WITH GGSIPU AND HAS NOT BEEN ALLOTTED ANY SEAT (THROUGH STATE/CENTRAL/AIQ ACROSS THE COUNTRY) AT THE TIME OF CONDUCT OF SPECIAL STRAY VACANCY ROUND.
- SUBMISSION OF CONSENT FOR PARTICIPATION IN THE SPECIAL STRAY VACANCY ROUND.
- EXERCISING OF "FRESH CHOICE FILLING".
- IF A CANDIDATE IS ALLOTTED A SEAT IN SPECIAL STRAY ROUND, HE/SHE HAS TO JOIN THE ALLOTTED SEAT/COLLEGE.

**WHO ARE NOT ELIGIBLE FOR ALLOTMENT:**

- CANDIDATE JOINED/HOLDING ANY SEAT (THROUGH STATE/CENTRAL/AIQ ACROSS THE COUNTRY).
- CANDIDATES ALLOTTED A SEAT IN STRAY VACANCY ROUND AND DID NOT FOLLOW THE REQUIRED PROCEDURE i.e. PAYMENT OF PART ACADEMIC FEE OF RS. 96000/-, VERIFICATION OF DOCUMENTS AND REPORTING AT THE ALLOTTED COLLEGE.
- CANDIDATE WHO BECOME IN-ELIGIBLE DUE TO HAVING INADEQUATE DOCUMENTS AS PER ELIGIBILITY CRITERIA.
- WHO HAVE NOT REGISTERED IN SPECIAL STRAY VACANCY ROUND.
- CANDIDATES WHO HAVE REGISTERED IN ROUND 1, 2, 3 & STRAY VACANCY ROUND AND HAVE NOT BEEN ALLOTTED ANY SEAT AND HAVE NOT SUBMITTED THEIR CONSENT FOR PARTICIPATION IN SPECIAL STRAY VACANCY ROUND.


