Instructions pertaining to foreign students

As part of our ongoing efforts to ensure compliance with immigration regulations, this communication serves as a reminder to all educational institutions hosting foreign students regarding their responsibility of providing relevant student information and ensure compliance of laws related to foreigners.

Important instructions in this regard are being re-enumerated as under:

1. Institutes must furnish Form A/ Form S within 24 hours of the admission of a foreign student.
2. Institutes must ensure that the foreign students are not engaged in any job/ occupation/ professional or commercial activity during their stay in India unless a suitable endorsement in this regard is made in their Student Visa sticker.
3. Institutes must provide information of any foreign student who is terminated or suspended by the institute, along with a statement of reason for such an action.
4. Institutes must maintain proper record of all the foreign students / faculty members residing in their campus in Form-B. They should also ensure filing of Form C for all such students / faculty members who are residing on their campus within 24 hours of their occupation of lodging as well as 24 hours after vacating lodge.
