Guru Gobind Singh Indraprastha University invites comprehensive *Curriculum Vitae* (CV) from the desirous and eligible candidates for the post of Advisor for Short Term duration appointment on Contract Basis as per University rules/ policy against a vacant post of Pay Level: 14. The appointment shall be purely on contract basis in the GGSIP University.

1. Eligibility & Experience

The candidate who has retired from Centre/ State Government/ Autonomous Bodies/ Academic/ Research Institutions/ Statutory Bodies of Government at the senior level and having vast experience in doctoring higher and technical education in culmination with Artificial Intelligence (AI) embedded programmes, having proven expertise in transformation of technical and higher education, research, innovation and have demonstrated in the establishment of Centre of Excellence in AI, Drone in Cyber Security and in Emerging Technologies. Besides, he/she should have been pioneer in the advancement of Industry Academia Government partnership with capabilities to deal and plan in multiple fields in a combined, coordinated, cohesive and efficacious manner. Having talent and expertise in setting up AI labs and having extensive experience of leadership quality and to comprehend futuristic based education plans and visions.

2. Age: Less than 69 years on the last date of submission of application for the post of Advisor.

3. Pay: The Advisor will be paid remuneration as per University norms/ policy depending upon the qualification, past experience etc.

4. Duties:

- (i) To work extensively in coordination with all the Heads of Schools/Centres of the University under single window system of the University.

- (ii) To draw the roadmap to embed and develop all programmes in sync with AI so that University able to have its mission, objective and vision materialized, which the University has engrained in its AI initiatives for all syllabus / programmes.



- (iii) To guide towards AI enabled for setting up of AI labs.
- (iv) Taking contemporary and futuristic initiatives essentially required to pace the academic landscape of education at par with the advanced countries.

5. Procedure for Selection:

The Selection on the post of Advisor shall be made by the Competent Authority on the basis of recommendation of the Selection/Screening Committee to be constituted for this purpose. This Selection/Screening Committee shall undertake comprehensive scrutiny of the profile of each candidate *inter alia* include academic background, consistency, work experience, achievements and skills based on work profile, accomplishment, extra/additional qualifications, leadership qualities etc. as may be highlighted by the candidate in the *Curriculum Vitae (CV)*. After evaluation and assessment of each candidate profile, the Selection/Screening Committee shall prioritize each candidate for their suitability to the post of Advisor. However, the final selection of the candidate shall be decided by the Competent Authority based on the recommendation of the Selection/Screening Committee.
